J.1. SUBJECT: Report for Discussion on Preliminary Annexation
Application #24-03 for the Old Dominion Annexation

REPORT IN BRIEF

The City Council will be asked to evaluate Preliminary Annexation

Application #24-03 for the Old Dominion Annexation project. The proposed annexation consists of approximately 260.5 acres, with a developed area of 170.3 acres. The project will include mixed-use development generally located north of Bellevue Road, between G Street and Golf Road, south of Farmland Road.

RECOMMENDATION

City Council - Adopt a motion indicating general support for an official annexation application being processed for the Old Dominion Annexation project.

Deputy Director of Development Services Diana LOWRANCE gave a slideshow presentation on the preliminary annexation application #24-03 for the Old Dominion Annexation.

Lee KOLLIGIAN, Applicant - spoke on the KOLLIGIAN family history, details of development projects, details of the community meetings, and addressed neighborhood concerns.

Ashley SUAREZ, Merced - spoke on the cost of pre-annexations and shared concerns of existing communities.

Robert DYLINA, Merced - spoke on unit resources, the impact fees, the cost of taxes, and higher prices for developing locally.

Mr. KOLLIGIAN spoke on ensuring the drain resources is feasible for all citizens.

Council discussed details of the project, the mixed housing density, and the impact on current annexations.

A motion was made by Council Member Dupont, seconded by Council Member Harris, in general support of the Old Dominion Annexation to move forward with the official annexation application. The motion carried by the following vote:

K.1. SUBJECT: Accept the Report on a Potential Rental Registry Program and Provide Direction

REPORT IN BRIEF

Considers accepting the report on a potential rental registry program and provide direction.

RECOMMENDATION

Accept the report on a potential rental registry program and provide direction to staff.

City Manager Scott MCBRIDE gave a slideshow presentation on a potential Rental Registry Program.

Council, Mr MCBRIDE, Police Chief Steven STANFIELD, and City Attorney Craig CORNWELL discussed inspection benefits, potentially providing training for public, the current efforts made by the Code Enforcement division, the receivership process, enhancing the Code Enforcement division, and the rental units that cause a large amount of issues.

Cindy KELLY, Merced - spoke on the calls received by Code Enforcement, government overreach, the rental registry will add costs to tenants, and asked Council not to support a rental registry.

Ashley SUAREZ, Merced - spoke on uninhabitable properties, the benefits of a rental registry, and shared suggestions to add to the rental registry program.

Blanca OJEDA, Merced - shared personal experiences with tenants in the community and spoke on similar policies like the rental registry program.

Terry BEALS, Merced - spoke on the need of a rental registry and shared details of the Brookdale Gardens apartment complex.

Earnest CHISM, Merced - shared his personal experience living in the Brookdale Gardens apartment complex, the conditions of the apartment complex, and spoke on the need for a rental registry.

Gloria SANDOVAL, Merced - spoke in support of a rental program, the benefits of a rental registry program, and the prevention of tenant and health issues.

Harold MIMS, Merced - spoke on their experience living in the Brookdale Gardens apartment complex.

Robert DYLINA, Merced - spoke on the complaints received by Code Enforcement, government overreach, and the concerns from landlords and

property owners.

Beverly SCHICK, Merced - spoke on holding property owners accountable.

Erin HAMM, Local Property Manager, Merced - asked Council to bring property owners and landlords into the discussion when making a decision on the rental registry program and spoke on the experience for inspectors.

Greg TERRAKIS, Merced - spoke on rental registry programs in other cities, the suggested price for each inspection, and suggested to look into an anti-slum enforcement team.

Latricia BEASLEY, Merced - spoke on behalf of the tenants living in the Brookdale Gardens apartment complex, the need of a rental registry, and asked Council to take action now on holding landlords accountable.

Larry MASENGALE, Merced - spoke on the issues that can incur if a rental registry program is adopted and asked to turn the rental registry program down.

Terry RUSCOE, Merced - spoke on getting immediate assistance to Brookdale Gardens residents and ensuring that tenants are being treated fairly.

Council, Mr. STANFIELD, Mr. MCBRIDE, and Mr. CORNWELL discussed providing information to tenants, the number of Brookdale Gardens resident complaints to Code Enforcement, the definition of a rental registry program and the rental inspection program, details of slum-lords, details of the Rental Registry Program in the City of Fresno, ways to enhance the Code Enforcement division, focus on an Anti-Slum-Lord Initiative, and previous conversations from City Council on a rental registry program. They also discussed the potential legal issues, publicly shaming bad landlords, details of the conditions of the Brookdale Gardens apartments, potentially a triage process for calls coming in for Code Enforcement, taking action on the Brookdale Gardens apartments as soon as possible, potentially creating a public list of residential homes and apartments with constant issues, details of housing issues, and public health and safety being a priority for Code Enforcement.

A motion was made by Council Member Smith, seconded by Mayor Pro Tempore Boyle, to reorient this initiative to focus solely on an Anti-Slum-Lord Initiative, look into different California cities, to no longer put resources to an Inspection Program and Rental Registry Program, with a deadline to come back to Council with 60-days, and an offer to put together a Subcommittee (Public Safety) with Council and community members for a focus group within 30 days. The motion carried by the following vote:

Cindy KELLY, Merced - spoke in support of this item, personal politics should not be on the agenda for discussion, and details of previous meetings.

Council spoke on previous Council meetings, previous discussions held, the benefits of the proposed amendment, discussing items in public meetings, public speakers, and the efficiency of the proposed amendment.

Ashley SUAREZ, Merced - spoke on the importance of citizens bringing issues to their district's Council Member.
