

FIRST AMENDMENT TO SERVICES AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this _____ day of _____, 2024, by and between the City of Merced, a California Charter Municipal Corporation ("City"), and ABS Direct, Inc., a California Corporation, whose address of record is 4724 enterprise Avenue, Modesto, CA 95356, ("Contractor").

WHEREAS, City is undertaking a project to conduct a Print and mail various notices and statements; and,

WHEREAS, City and Contractor have previously entered into an Services Agreement ("Agreement") dated June 3, 2019; and,

WHEREAS, City and Contractor desire to amend said Agreement to provide for additional services in connection with said project.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 3, "TERM OF AGREEMENT," is hereby added to the Agreement to read as follows:

"The Term of this amendment shall extend existing contract through December 31, 2025."

2. Section 4, "ADDITIONAL COMPENSATION," is hereby added to the Agreement to read as follows:

"SECTION 4, "Payment by the City to the Contractor for actual services rendered under this Agreement shall be made upon presentation of an invoice detailing services performed under the Scope of Services, in accordance with the updated Fee Schedule set forth in the proposal attached hereto as Exhibit "A" and in accordance with the rates set forth on Exhibit "B."

3. Except as herein amended, the Agreement dated June 3, 2019 shall remain in full force and effect.
