City shall pay to Consultant the not to exceed additional sum of Eighty Thousand Dollars (\$80,000.00) for work performed under the Agreement."
2. Except as herein amended, the Agreement dated January 10, 2023, First Amendment dated March 27, 2024, and Second Amendment dated April 15, 2024, shall remain in full force and effect.
