Interim Fire Chief Casey WILSON and City Manager Scott MCBRIDE gave a slideshow presentation on the potential fire services and emergency

operations coordination with Merced County.

Council and Mr. WILSON discussed the terms of the city and county agreement, the effects on the computer-aided dispatch (CAD) and response times, potential delays in response times for specific locations, firefighter safety issues, the necessary response team for structure fires, the capacities of a single fire station, the benefits of adding resources to North stations, and funding for equipment.

Josh PEDROZO, Merced County Board Supervisor - spoke on the funding of the CAD system and asked to allow city staff to collaborate with Merced County.

Council and Mr. WILSON discussed the data regarding the impact of response times, the Merced County budget, details of the city resources that will be used for county, details of the mutual aid request, financial impact, and staff recommendation.

A motion was made by Mayor Pro Tempore Perez, seconded by Council Member Smith, to continue this item, accepting staff recommendation (supporting further conversations to develop fair and equitable partnerships with Merced County to enhance fire services within the City of Merced and Merced County jurisdictions and staff bringing back options for Council's consideration).
