

**FIRST AMENDMENT TO AGREEMENT FOR
SALES TAX AUDIT AND INFORMATION SERVICES**

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this 15th day of June, 2009 by and between the City of Merced, a California charter municipal corporation ("City"), and Hinderliter, De Llamas & Associates, a California corporation ("Contractor").

WHEREAS, City and Contractor have previously entered into an Agreement for Sales Tax Audit and Information Services ("Agreement") dated July 15, 1996; and,

WHEREAS, City and Contractor desire to amend said Agreement.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section II, "SERVICES," subsection A, "Sales Tax and Economic Analysis," of the Agreement is hereby omitted.
2. Section II, "SERVICES," subsection C, "On Going Consultation," is hereby amended to read as follows:

"C. Examination of Transactions and Use Tax Records. Pursuant to the authority originally granted by Resolution 2005-144, Contractor is hereby authorized to examine the transactions and use tax records of the City of Merced pertaining to transactions and use taxes collected for the City by the State Board of Equalization."
3. Section V, "CONSIDERATION," subsection A of the Agreement is hereby omitted.
4. Except as herein amended, the Agreement dated July 15, 1996, shall remain in full force and effect.
