Units, as Well as Reconfiguring the Location of Various Buildings on
the Site

REPORT IN BRIEF

This application is to modify the Site Utilization Plan (SUP) for the Yosemite Crossing Development at the northeast corner of Yosemite Avenue and G Street to allow inclusion of a car wash, additional retail buildings, realignment of the uses on-site, and an increase of 52 multi-family units from 44 (approved) to 96 (proposed).

RECOMMENDATION

City Council- Adopt a motion:

- A. Approving Environmental Review #21-18 (CEQA Section 15162 Findings); and,
- B. Introducing **Ordinance 2534**, an Ordinance of the City Council of the City of Merced, California, approving Site Utilization Plan Revision #4 to Planned Development (P-D) #72 to include a car wash, additional retail buildings and 52 additional multi-family units, as well as reconfiguring the location of various buildings on the site; and,
- C. Approving the amendment to the Legislative Action Agreement; and,
- D. Authorizing the City Manager or the Deputy City Manager to execute all related documents.

Principal Planner Michael HREN gave a presentation on the changes requested by the developer of the Yosemite Crossing Development at the northeast corner of Yosemite Avenue and G Street to allow inclusion of a car wash, additional retail buildings, realignment of the uses on-site, and an increase of 52 multi-family units from 44 to 96.

Mayor SERRATTO opened the Public Hearing at 7:07 PM.

Neil ANGELLILO, Manager of Yosemite & G, LLC - gave a brief overview of the project, spoke about the addition of a car wash, additional partners acquired to assist with the development and explained the need to add additional housing in order to have on site management of the complex.

Council briefly asked questions of the developer and their partners regarding the project including the need for additional apartments added to the plan.

Donna HUNTER, Merced - spoke in opposition of adding additional apartments to the project.

Karen PATTERSON, Merced - spoke in opposition of adding additional apartments and suggested closing the openings at the end of the cul-de-sacs.

Anthony AQUINO, Merced - expressed concerns about people seeing into the neighborhood backyards.

Shawn HENRY, Merced - expressed concerns with increasing the number of apartment units and asked that Council stick with the original proposal.

Fue XIONG, Merced - spoke in support of adding additional units to the apartments to help alleviate the housing crisis in Merced.

Genevieve RASMUSSEN, Merced - spoke against adding additional apartment units to the project.

Michael BELLUOMINI, Merced - spoke in favor of the project but suggested design changes to the apartment building layout.

Russel LAWRENCE, Merced - spoke in opposition to the project and expressed concern with the parking and traffic that will be created.

Monique GAMA, Merced - spoke in support of the project.

Beth LAWRENCE, Merced - expressed traffic and safety concerns with the additional units proposed to the apartment complex.

Pancha VANG, Merced - expressed support for the project.

Rick SANFORD, Merced - expressed concerns with the increased traffic to the area.

Carmen, Merced - spoke in opposition to the requested increase in the number of apartments due to safety concerns.

Council, Mr. ANGELLILO and staff discussed the requested increase in

units, the onsite management for the apartments, and the potential to increase the wall height on Sandpiper Avenue.

Mayor SERRATTO closed the Public Hearing at 8:07 PM.

Council continued to discuss the project and possible concessions, safety concerns and the need for housing.

A motion was made by Council Member Shelton, seconded by Council Member Echevarria, that this agenda item be approved as amended to allow the car wash, the rearranging of buildings on the site, but to only allow the originally approved 44 apartment units. The motion failed by the following vote:
