

Conditions of Approval
Planning Commission Resolution #3076
Conditional Use Permit #1215

1. The proposed project shall be constructed/designed as shown on Exhibit 1 (floor plan) -- Attachment B of Staff Report #17-03, except as modified by the conditions.
2. All conditions contained in Resolution #1249-Amended (“Standard Conditional Use Permit Conditions”—except for Condition #16 which has been superseded by Code) shall apply.
3. The developer/applicant shall indemnify, protect, defend (with counsel selected by the City), and hold harmless the City, and any agency or instrumentality thereof, and any officers, officials, employees, or agents thereof, from any and all claims, actions, suits, proceedings, or judgments against the City, or any agency or instrumentality thereof, and any officers, officials, employees, or agents thereof to attack, set aside, void, or annul, an approval of the City, or any agency or instrumentality thereof, advisory agency, appeal board, or legislative body, including actions approved by the voters of the City, concerning the project and the approvals granted herein. Furthermore, developer/applicant shall indemnify, protect, defend, and hold harmless the City, or any agency or instrumentality thereof, against any and all claims, actions, suits, proceedings, or judgments against any governmental entity in which developer/applicant’s project is subject to that other governmental entity’s approval and a condition of such approval is that the City indemnify and defend (with counsel selected by the City) such governmental entity. City shall promptly notify the developer/applicant of any claim, action, or proceeding. City shall further cooperate fully in the defense of the action. Should the City fail to either promptly notify or cooperate fully, the developer/applicant shall not thereafter be responsible to indemnify, defend, protect, or hold harmless the City, any agency or instrumentality thereof, or any of its officers, officials, employees, or agents.
4. The developer/applicant shall construct and operate the project in strict compliance with the approvals granted herein, City standards, laws, and ordinances, and in compliance with all State and Federal laws, regulations, and standards. In the event of a conflict between City laws

and standards and a State or Federal law, regulation, or standard, the stricter or higher standard shall control.

5. Sufficient lighting shall be provided throughout the site to provide a safe environment for employees and patrons of the business.
6. All landscaping shall be kept healthy and maintained in good condition and any damaged or missing landscaping shall be replaced immediately.
7. The premises shall remain clean and free of debris and graffiti at all times. Any damaged materials shall be replaced by matching materials.
8. A temporary banner permit shall be obtained prior to installing any temporary signs. Free-standing temporary signs (i.e., sandwich boards, A-frame signs, etc.) are prohibited.
9. The proprietor and/or successors in interest and management shall be prohibited from advertising or promoting beer & wine and/or distilled spirits on the building or in the windows. No self-illuminated advertising for beer or wine shall be permitted.
10. No beer or wine shall be displayed or stored outside of the cooler areas.
11. No display or sale of beer or wine shall be made from an ice tub.
12. Employees on duty between the hours of 9 p.m. and 11 p.m. shall be at least 21 years of age to sell alcohol.
13. Alcohol sales shall cease by 11:00 p.m. regardless of the business hours for the store in general.
14. The proprietor and/or successors in interest and management shall comply with all Municipal Codes relating to loitering, open container laws and other nuisance-related issues.
15. The area within the convenience market dedicated to the display and sale of alcoholic beverages (beer and wine) shall not be more than 6 cooler spaces (typical of those found in a grocery store or convenience market) or 176 square feet. The display of liquor shall be located behind the cashier and not exceed 60 square feet.
16. The City reserves the right to periodically review the area for potential problems. If problems (on-site or within the immediate area), including but not limited to, public drunkenness, the illegal sale or use of narcotics, drugs or alcohol, disturbing the peace, and disorderly conduct result from the proposed land use, the conditional use permit may be subject to

review and revocation by the City of Merced after a public hearing and in conformance with the procedures outlined in the Merced Municipal Code.

17. No single-serving containers shall be sold separately unless authorized by the City of Merced Police Department. All single-serving beer and wine containers shall be sold as part of a pack or carton.
18. The business shall comply with all applicable requirements from the Merced County Health Department.
19. Prior to obtaining a license from the Alcoholic Beverage Control to sell alcohol, the business (for the convenience market) shall obtain approval for a Finding of Public Convenience or Necessity from the Merced City Council.
20. This approval is subject to the business owner being in good standing with all laws of the State of California, including the Alcohol Beverage Control (ABC), City of Merced, and other regulatory agencies.

Mr. SAGIN stated that the original plan included a much larger police force and the forecast population growth for the city was not as first expected.

Council Member BELLUOMINI suggested building the new facility with future growth in mind. He questioned the future ability to expand.

Mr. SAGIN reported that the site had room to expand the building when needed.

Council Member BELLUOMINI questioned administrative fees.

Mr. SAGIN stated that there are extra fees for the architect to oversee the project.

Council briefly discussed the square footage needed based on sworn officers and population numbers.

Chief Deputy City Attorney Kelly FINCHER and Police Dispatch Supervisor Marvin DILLSAVER gave a slide presentation on false alarms. Types of alarms and top offenders were noted. Impacts on police resources were noted including the estimated costs of false alarms.

Ms. FINCHER highlighted different sections in the ordinance and spoke on the public schools' concerns.

Mayor THURSTON expressed concern with the two-tier payment system.

City Manager Steve CARRIGAN stated that the two-tier system had come from a meeting with the School Districts.

Council Member DOSSETTI asked about armed robberies or burglaries.

Ms. FINCHER mentioned special code words that alarm companies have in order to protect businesses and owners.

Clerk's Note: Mayor THURSTON opened the Public Hearing at 7:55 PM.

Greg SPICER, Merced City School District - stated the Districts would like to see the two-tier system.

Mayor THURSTON stated that a \$25.00 penalty may not be enough.

Rosemary PARGA-DURAN, Merced City Schools Superintendent - voiced support for the two-tier system.

Council Member MURPHY expressed concern that the schools were not progressing fast enough.

Mark GOTTSHEL, Merced High School District - Spoke on education needed and actual alarms versus false alarms.

Spencer DAVIES, Merced - spoke about privatizing the response to alarms.

Necola ADAMS, Merced - stated that substitute teachers could be causing false alarms and that suspects could be gone by the time Police arrive.

Clerk's Note: Mayor THURSTON closed the Public Hearing at 8:24 PM.

Council Member BLAKE expressed support for option B.

Council Member BELLUOMINI proposed changes to the ordinance.

Mayor Pro Tempore PEDROZO stated support for option B.

Council Member MURPHY stated support for a two-tier payment system with sunset language included in the ordinance.

C. STUDY SESSION

C.1. **SUBJECT:** Medical Marijuana Study Session

REPORT IN BRIEF

Provides a brief overview of medical marijuana issues at the state and local level, answers questions raised by the City Council relating to medical marijuana, and outlines potential amendments for the City Council to consider regarding existing bans on medical marijuana dispensaries, deliveries and cultivation.

RECOMMENDATION

Staff recommends that the City Council take public testimony regarding the medical marijuana issue as it relates to dispensaries, deliveries and cultivation within the City of Merced and either:

A. Provide direction to staff regarding specific modifications to the City's existing bans on dispensaries, deliveries and/or cultivation of medical marijuana within the City; or,

B. Schedule another study session on this matter regarding medical

marijuana in general or specifically relating to dispensaries, deliveries and/or cultivation; or,

C. Take no further action regarding medical marijuana at this time.

Senior Deputy City Attorney Ken ROZELL gave a slide presentation with nine questions regarding dispensaries, delivery, and cultivation of Marijuana to be answered in order to draft an ordinance. He gave an overview of some regulations in other jurisdictions. He also touched on regulations and problems in some larger Cities, including San Francisco, San Diego, and Los Angeles.

He briefly described the active ingredients in Marijuana, including THC and CBD, and discussed obtaining a Medical Marijuana Card.

Council Member MURPHY questioned delivery.

Mr. ROZELL stated that the Council would need to take a position on delivery.

Mayor Pro Tempore PEDROZO asked about regulating dispensary locations within a certain zone.

Mr. ROZELL stated that restrictions could be put on the location within a zone, such as proximity to a Church or School.

Charles VEILLEUX and Rex PETERSON, Merced - discussed their proposal on opening a dispensary.

Mayor THURSTON questioned the number of dispensaries needed for Merced.

Mr. PETERSON suggested that eight dispensaries would be appropriate for Merced.

Kathy RODRIGUEZ, Merced - spoke against Medical Marijuana.

Patricia PERRY, Merced - spoke against Medical Marijuana, citing reports that long-term use causes brain damage.

Mellissa HERNANDEZ, Merced - asked what the process will be for choosing the dispensaries.

Susan BOUSCAREN, Merced - discussed the expense of growing Marijuana indoors.

Sae SAECHOW, Merced - spoke for the Mien community in favor of outdoor growing.

Kevin BAUER and Emery SILVERMAN, Merced - spoke about the LED grow light they have developed that will use much less energy than standard grow lighting.

Sister KATE, Merced - spoke in favor of Medical Marijuana.

Monica VILLA, Merced - spoke on various aspects of Medical Marijuana use.

Dwight LARKS, Merced - spoke in favor of outdoor growing and dispensaries.

Council Member BLAKE favored 3 dispensaries in commercial office zones at least 500 ft from schools, deliveries by licensed dispensaries and indoor or outdoor growing not to exceed 12 plants.

Council Member BELLUOMINI favored dispensaries for medical purposes only in the commercial office zone. He suggested 4 or 5 dispensaries for competition and expressed concern with deliveries and not to allow cultivation.

Council Member DOSSETTI favored dispensaries with tested product, deliveries and growing 6 plants indoors or outdoors for personal use.

Council Member LOR suggested no limit on the number of dispensaries and would consider commercial growing.

Mayor THURSTON inquired about commercial growing.

Mr. ROZELL stated the license for commercial growing will be state-issued in the future.

Mayor THURSTON favored dispensaries in commercial office zones with delivery. He also favored growing 12 plants indoors only. He stated that he was opposed to selling items that could be smoked.

Clerk's Note: Mayor THURSTON called for a recess at 6:44 PM and resumed the meeting at 6:49 PM.

Council Member MURPHY favored dispensaries in commercial office

zones with a conditional use permit process. He stated support for deliveries from a licensed dispensary. He supported indoor or outdoor cultivation of 6 mature plants, but not to be in the view of the public.

Mayor Pro Tempore PEDROZO agreed with most of the statements, but disagreed with the outdoor growing of plants. He favored indoor growing with 4 or 5 plants. He also stated the deliveries should be done only by licensed dispensaries. He agreed that 4 dispensaries would be appropriate.

Council Member BELLUOMINI asked for clarification on the conditional use permit and the ability to limit the number of dispensaries.

Planning Manager Kim ESPINOSA stated that using the permit to deny a business would be difficult after approving others under the same conditions.

Council Member MURPHY asked about the lag time between the City and State regulations.

Mr. ROZELL stated that because of the dual licensing, a dispensary cannot open until they obtain both a State license and City-issued permit.

City Manager CARRIGAN polled the Council on the questions posed in order to assist Mr. ROZELL in drafting an ordinance.

Police Chief ANDRADE came to the podium to remind the audience about disruptions and the process involved for those who wish to speak.

Council discussed the many options for cultivation as far as indoor and outdoor and immature versus mature plants. Council also discussed requirements for outdoor grows as far as setback and visibility to the public.

Monica VILLA, Merced - discussed growing plants outdoors.

Andrew BLAINE, Merced - spoke about commercial growing and testing of Marijuana.

Eric MOORE, Merced - commended Council for having the meeting and getting public input. He suggested looking at Marijuana from an economic standpoint as well.

Sae SAECHOW, Merced - thanked the Council for allowing citizen input.

SUBJECT: Street Closure #17-01 - Street Closure Request for the Merced County Fair (Merced County Sheriff's Department)

REPORT IN BRIEF

Consider a request for use of City streets for the Merced County Fair.

RECOMMENDATION

City Council - Adopt a motion approving the street closure of G Street, between West Childs Avenue and West 11th Street, from 5:00 p.m. to 12:00 a.m. each day, from Wednesday, June 7, 2017, through Sunday, June 11, 2017, for the Merced County Fair, subject to the details and conditions outlined in the administrative staff report.

ALTERNATIVES

1. Approve, as recommended by staff; or,
2. Approve, subject to modifications as conditioned by Council; or,
3. Deny; or,
4. Refer back to staff for reconsideration of specific items as requested by Council; or,
5. Continue to a future meeting (date and time to be specified in the motion).

AUTHORITY

City of Merced Charter Section 200; California Vehicle Code (CVC) Section 21100(a), as follows:

"21100. Local authorities may adopt rules and regulations by ordinance or resolution regarding the following matters:

(a) Regulating or prohibiting processions or assemblages on the highways."

CITY COUNCIL PRIORITIES

DISCUSSION

The Merced County Sheriff's Department, along with the 35th District Agricultural Association, is requesting closure of City streets in conjunction with the Merced County Fair, to be held June 7, 2017, through June 11, 2017.

The Merced County Fairgrounds is bordered by Martin Luther King Jr. Way, West 11th Street, G

Street, and West Childs Avenue (Attachment 1).

Street Closure Details

The street involved in this request is G Street, from West/East Childs Avenue to West/East 11th Street. The street section will be used to route cars to specific fair parking areas, but will be closed to through traffic. Through access will be provided to emergency vehicles only.

The Merced County Sheriff's Department plans to set up coned-off "traffic lanes" to help guide vehicles wishing to park in the east parking lot. The general public will only be permitted access to the lot from the intersection of West/East 11th and G Streets, while only Fair-related traffic (i.e. livestock exhibitors, fair personnel, etc.) will be allowed access from Childs Avenue.

By restricting access to through traffic in this manner, the Sheriff's Department is able to establish a "safe zone" pedestrian crossing area from the parking lot to the Fairground's eastern entrance gate each day of the fair. Safety is especially important here, as the Kiddie Carnival area is located just inside the gates at this side of the Fairgrounds. In addition to providing families close parking to the Kiddie Carnival area, the eastern parking lot also serves as overflow parking for the northern parking lot on West 11th Street (Attachment 2).

The following are the planned times of the street closure, along with the official Fair hours:

- Street Closure hours: 5:00 p.m. to Midnight, each day of the Fair.
- Fair hours: Wednesday - Friday, 5:00 p.m. through 12:30 a.m.; and Saturday and Sunday, 3:00 p.m. to 12:30 a.m.

Event Background

First held in 1891, the Merced County Fair has been a fixture on regional event calendars each year, drawing crowds of approximately 10,000 each day. In 2010, to accommodate the State Fair's new schedule, the Merced County Fair moved from each July to each June, allowing fairgoers to enjoy the slightly more temperate temperatures of late spring/early summer.

Conditions of Approval

The street closure will be subject to the following conditions, if approved:

1. By applying for the street closure request, the Permittee shall agree to indemnify, protect, defend (with counsel selected by the City), save, and hold the City, its officers, employees, agents, and volunteers harmless from any and all claims or causes of action for death or injury to person, or damage to property resulting from intentional or negligent acts, errors, or omissions of Event Sponsor or Event Sponsor's officers, employees, agents, volunteers, and participants during performance of the Event, or from any violation of any federal, state, or municipal law or ordinance, to the extent caused, in whole or in part, by the willful misconduct, negligent acts, or omissions of Event Sponsor or its officers, employees, agents, and volunteers, except for loss caused solely by the gross

negligence of the City. Acceptance by the City of insurance certificates and endorsements required for this Event does not relieve Event Sponsor from liability under this indemnification and hold harmless clause. This indemnification and hold harmless clause shall apply to any damages or claims for damages whether or not such insurance policies shall have been determined to apply.

2. Prior to closing any streets, Event sponsor shall complete and file with the City a special events, general liability, and automobile policy of at least \$500,000 combined limit for bodily injury and property damage which covers the entire event. Said policy shall stipulate that this insurance will operate as primary insurance and that no other insurance will be called on to cover a loss covered thereunder. Additional insured endorsements evidencing this special events, general liability and automobile coverage, naming the city and its officers, agents, and employees as additional insureds, must be submitted to the City prior to the event. This certificate shall provide that thirty (30) days written notice of cancellation shall be given to the City.

3. Event Sponsor shall contact all businesses and residences affected by the street closures, advising of the hours, conditions, and reason thereof within one half-mile of the closure area at least seventy-two (72) hours prior to the event. Event Sponsor shall provide the City with signed confirmation that the proper notification was given (Attachment 3).

4. Event Sponsor shall be responsible for placing and removing all traffic barricades and posting of parking restrictions where the street will be closed. Specifically, where parking is currently permitted on the proposed closed section of G Street, the applicant shall post "No Parking" signs for the duration of the Fair on both the east and west sides to ensure the street is clear. Any parked vehicles remaining at the start of the Fair shall be towed away. "No Parking" signs shall be posted at least twenty-four (24) hours prior to the towing of vehicle(s) per California Vehicle Code Section 22651(m).

5. Event Sponsor shall maintain a minimum 22-foot-wide emergency vehicle travel lane through the interior of the closure area at all times. Fire hydrant access shall not be blocked at any time whatsoever.

6. Event Sponsor shall provide staffing at or near all barricades, so that personnel is on-hand and readily available to move barricades aside for emergency vehicles, Fair equipment, or other such authorized vehicles to pass through quickly and unobstructed, in the event this is necessary.

7. Event Sponsor shall provide additional sworn personnel and directional signage throughout and surrounding the closure area and all affected intersections to ensure the safe flow of traffic.

8. The Event Sponsor shall make a concerted effort to employ more parking lot attendants in all Fairgrounds parking lots, in order to effectively move vehicles through the lots and reduce traffic congestion.

9. The Event Sponsor shall maintain a dedicated "pedestrian zone" within the closed section of G Street. All areas of the pedestrian zone shall be handicapped accessible, per ADA requirements.

10. To aid the traffic flow of fairgoers leaving the area, the Fair shall make available the use of the G

Street parking lot's rear gate at the elbow intersection of East 9th and E Streets. The Event Sponsor shall ensure that the driveway is clear of obstructions for the safe passage of vehicles out of the parking lot. If the gate is used, additional sworn officer personnel shall be placed at both adjacent intersections at E Street/East 11th Street and D Street/East 9th Street to direct traffic onward. Actual use of this gate shall be at the discretion of the Fair/Sheriff's Department; however, it shall be readied and made available in the event it is needed to ease traffic congestion and/or public safety issues or concerns.

11. If needed, the Event Sponsor shall also make use of the G Street side gate at the northern paved West 11th Street parking lot for moving overflow parking to the eastern G Street parking lot.

12. Event Sponsor shall be responsible for removing all equipment and disposing of any trash and debris within and around the closure area that is generated from the Fair event prior to the expiration of the closure permit each day.

13. All other provisions addressed in Ordinance #1941, Chapter 12.42 (Temporary Street Closures) shall apply.

History and Past Actions

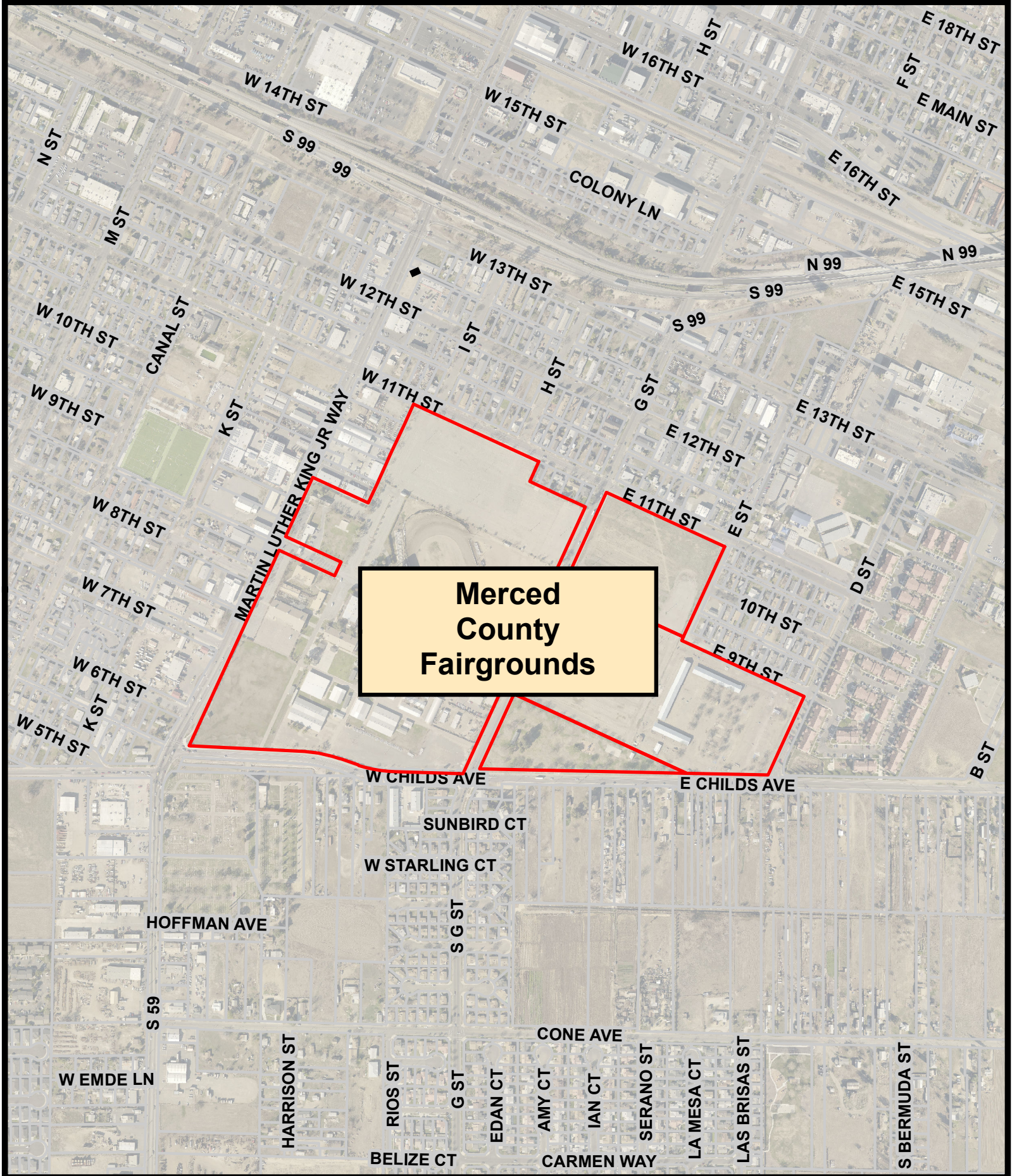

As all traffic control will be handled by the Sheriff's Department and volunteers, no impact to City resources is expected.

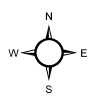

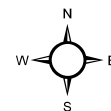
LOCATION MAP: Street Closure #17-01

SUBJECT: Use of the Economic Opportunity Fund to Contribute Toward Public Storm Drain Improvements at the Intersection of South Parsons Avenue and East Childs Avenue

REPORT IN BRIEF

Staff is seeking City Council approval for the use of the Economic Opportunity Fund to contribute toward the construction of public storm drainage facility improvements at the intersection of South Parsons Avenue and East Childs Avenue. If approval is obtained, a future agenda item will be brought before the City Council seeking authority to execute a cooperative agreement for the proposed Merced Retail Center.

RECOMMENDATION

City Council - Adopt a motion directing staff to use the Economic Opportunity Fund to contribute toward public storm drain improvements at the intersection of South Parsons Avenue and East Childs Avenue; and instructing Staff to report back with a Cooperative Agreement with Merced Retail Center developer to construct said public improvements for Council approval.

CITY COUNCIL PRIORITIES

As provided for in the Fiscal Year 2016-17 Adopted Budget.

DISCUSSION

The Merced Retail Center development is located at the southwest corner of the intersection of East Childs Avenue and South Parsons Avenue (Attachment A). This 3.2-acre lot previously had a bowling alley that has recently been removed. The development proposes to construct three new buildings that will operate a Kentucky Fried Chicken, Steak 'N' Shake, and an ARCO am/pm gas station

(Attachment B).

This intersection currently has no underground storm drain infrastructure and the streets convey the storm water. This results in flooding at the intersection during moderate storm events.

Although the proposed redeveloped project results in slightly less storm water runoff than the existing condition, the City staff is recommending to not allow any additional discharge of storm water into the road due to the existing flooding issues in the area. There is an existing drainage system to the south of the proposed development that is reasonably close for a pipeline connection. However, this system outfalls to the Dinkey Creek Avenue pump station that is at capacity. In addition, new state storm water discharge requirements have significant effects on the redevelopment of this site due to on-site detention. All of these factors have added unanticipated costs to Merced Retail Center development and is potentially jeopardizing its economic viability.

Therefore, a new pipeline is now proposed that would connect the development's storm water run-off and the public street drainage into an existing drainage system that is located approximately 300 feet north of the development in South Parsons Avenue (Attachment C). The "Joe Herb" Storm Water Basin has available capacity. The City will benefit from this proposed public storm drainage system in many ways:

- Elevates street flooding at the intersection of East Childs Avenue and South Parsons Avenue; and,
- Provides relief to the existing Dinkey Creek Avenue storm drain basin; and,
- Provided economic development benefit to the community in the form of property taxes, jobs, and payroll.

Economic Development Opportunity Fund: Staff is requesting authorization to set aside \$61,618.75 from the Economic Development Opportunity Fund for the project-related storm water improvements at Childs Avenue and Parsons Avenue. The purpose of the Economic Development Opportunity Fund is to provide assistance to developments that would otherwise not be feasible, yet provide an economic development benefit to the community and support job creation opportunities. Paying for a portion of the improvements will help retain the commercial project at the subject site and the benefits the project brings to the community.

With the adoption of the FY 16-17 Budget, the Economic Development Opportunity Fund was established and direction was provided to return to the Council with a policy that outlines the use of the funds. The policy is being developed and will be brought to the Council for adoption within the next two months to ensure that funds set aside are allocated consistently and equitably.

The Project & Benefits: The project includes the construction of the three national Quick Serve Retailers, Arco, Steak 'N' Shake, and Kentucky Fried Chicken on a 3.2-acre site formally known as Century Bowl. The value of the land and three buildings is estimated at \$12-million (not including machinery and equipment.) Approximately \$120,000 would be paid annually in property taxes. The

project also has the capacity to generate 114 jobs with a combined payroll of \$2.95-million per year.

After Century Bowl closed its doors, the building became blighted. Via FaceBook, a Town Hall meeting, and a City Council meeting, residents in the neighborhood complained that the dilapidated building was an eyesore. The building is now demolished, and the developer secured approvals to move forward with all Quick Serve Retailers.

The added costs to enhance the storm water system at the intersection of Childs Avenue and Parsons Avenue was not anticipated by the developer. Paying a portion of the improvement costs from the Economic Development Opportunity Fund would help retain the project and its economic benefits including an investment of \$12-million, 114 jobs, and a combined payroll of \$2.95-million per year.

Staff is recommending a contribution from the Economic Opportunity Fund to cover a proportionate share of the cost of construction of drainage improvements that would provide a benefit to the city. The cost share is proposed to be a pro-rata allocation of the construction costs based on public street drainage quantity conveyed in the pipeline (25%) versus the private development drainage quantity conveyed (75%). The estimated costs are outlined in Attachment D, with the City share of \$61,618.75.

The terms of the cooperative agreement will be for the City to reimburse the Merced Retail Center developer based upon occupancy of the proposed buildings. This cooperative agreement will be brought to the City Council for approval.

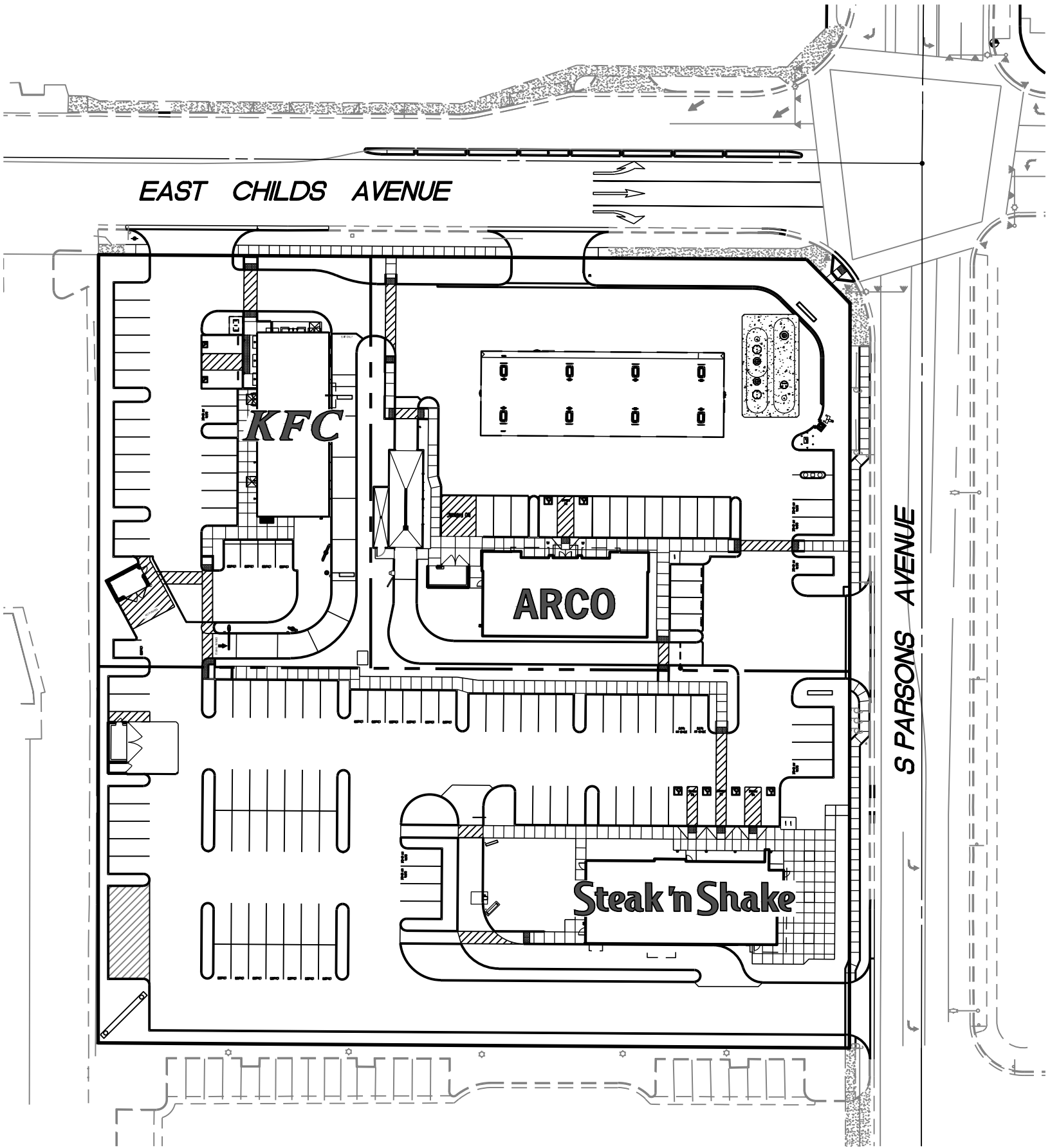

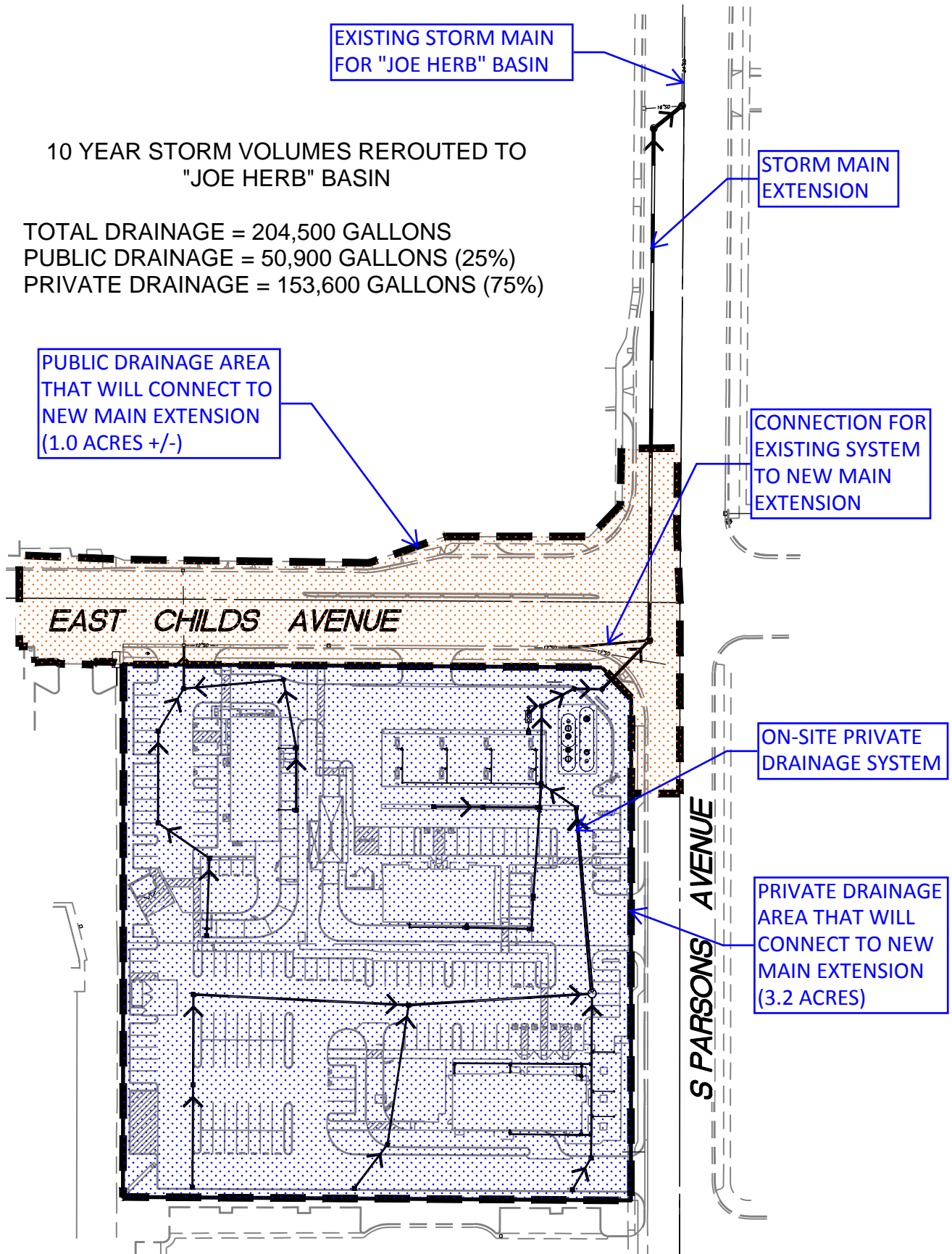

DISCUSSION

The State Water Resources Control Board is considering new rules regarding the regulation of flows on the Merced, Stanislaus and Tuolumne Rivers. This proposal would increase the unimpaired flows of the rivers by 40 percent, which would have a devastating effect on the region, severely impacting agriculture and altering local groundwater recharge.

The Board held several hearings on the subject, including one on December 19, 2016 in Merced. Council members testified at the Merced hearing regarding their concerns and opposition to the

proposal. Staff traveled to Sacramento to present testimony in opposition to the proposal. The City Manager and Economic Development Director sent letters in December opposed to the proposal.

Early this month staff received a request from Assemblyman Adam Gray's office for another letter in opposition to the Draft Revised Substitute Environmental Document. The request came too late to be included on the agenda for the March 6 City Council meeting, however the Assemblyman needed the letter before the March 20 meeting. In light of the City's previous opposition to the proposal, staff drafted a letter and it was signed by the Mayor. Staff is seeking formal Council support for the letter at this meeting.

Staff plans to bring before Council a complete Legislative Platform in the weeks ahead for its discussion and approval. Once a Legislative Platform is approved, staff will be able to respond quickly to requests for letters and to legislative actions, as needed, based on the contents of the adopted platform.

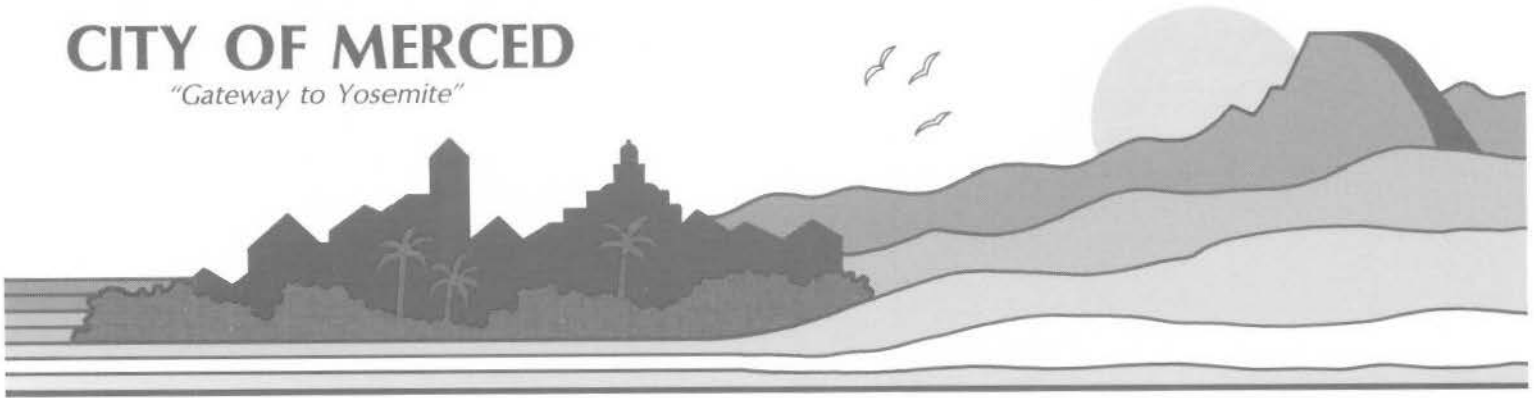

I'm writing to express the grave concerns with the State Water Resources Control Board's proposed actions on behalf of the City of Merced and our 82,000 residents in the Central Valley.

It is imperative to us that our distress over your proposal is included in the official record on the Draft Revised Substitute Environmental Document (SED). We urge you once more to heed the requests of the numerous cities, school districts, and concerned residents who have voiced their opposition to the Bay-Delta Plan. In an area that is largely dependent on agriculture, a proposal that increases the unimpaired flows of the Merced, Stanislaus, and Tuolumne rivers by 40% would devastate a region that has only just now begun to heal from five years of drought.


The public hearings held in Merced and Modesto this past December provided ample evidence that local stakeholders have been left out of a process that will severely impact every aspect of their lives. Safe and reliable access to drinking water, our economic vitality, and our very way of life would be jeopardized by your proposed plan.

Given the serious implications of your proposal, there should have been a credible effort to involve us throughout the development phase, but this simply didn't happen. By allowing stakeholders to comment on the plan only after it was released, you have excluded our region from providing valuable local knowledge that could have been used by your scientists and technical experts to create a plan that appropriately balances the competing priorities under your consideration.

I urge you to give consideration to the voices of our community and revise the current plan to reflect the needs of all the parties involved.

**THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Chapter 1.08, "City Seal," of the Merced Municipal Code is hereby amended to read as follows:

**"CHAPTER 1.08
CITY SEAL**

Section:

- 1.08.010 City Seal.**
- 1.08.020 Custodian.**
- 1.08.030 Use of City Seal.**
- 1.08.040 Penalty.**

1.08.010 City Seal.

The common seal of the City is hereby adopted and described as follows:

A palm tree, a fountain, and a waterfall, so arranged that the palm tree shall occupy the central space of the seal, the fountain on the right, and the waterfall on the left of the palm tree, surrounding which, in the margin of the seal shall appear the words, 'City of Merced, California, Incorporated April 1, A. D. 1889.'

1.08.020 Custodian.

As provided for in Section 602(D) of the Charter, the City Clerk shall be the custodian of the City Seal.

1.08.030 Use of City Seal.

A. It shall be unlawful for any person or group to make or use the seal of the City of Merced, or any derivation, rendering, version, expression, logo, stamp or reproduction thereof, for any purpose other than for the official business of the City of Merced, its City Council, officers or departments, except upon approval of the City Council by resolution.

B. No person or group shall place any imitation of the City Seal, nor any derivation, rendering, version, expression, logo, stamp or reproduction thereof, on any written, printed or electronic material that is designed, intended or likely to confuse, deceive or mislead the public or cause the reader of such material to believe it to be an official city publication.

C. It shall be unlawful for any person or group to place the City Seal, or any derivation, rendering, version, expression, logo, stamp or reproduction thereof, on any written, printed or electronic material in favor of or against any ballot measure, or in favor of or against any candidate for public office.

1.08.040 Penalty.

A violation of this Chapter is a misdemeanor, punishable in accordance with Chapter 1.12 of this Code. At the discretion of the City, this Chapter may also be enforced by use of civil or administrative remedies.”

SECTION 2. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 3. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 4. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.

SECTION 1. AMENDMENT TO CODE. Chapter 1.08, "City Seal," of the Merced Municipal Code is hereby amended to read as follows:

**"CHAPTER 1.08
CITY SEAL**

- 1.08.010 City Seal.**
- 1.08.020 Custodian.**
- 1.08.030 Use of City Seal.**
- 1.08.040 Penalty.**

1.08.010 City Seal.

The common seal of the City is hereby adopted and described as follows:

A palm tree, a fountain, and a waterfall, so arranged that the palm tree shall occupy the central space of the seal, the fountain on the right, and the waterfall on the left of the palm tree, surrounding which, in the margin of the seal shall appear the words, 'City of Merced, California, Incorporated April 1, A. D. 1889.'

1.08.020 Custodian.

As provided for in Section 602(D) of the Charter, the City Clerk shall be the custodian of the City Seal.

1.08.030 Use of City Seal.

A. It shall be unlawful for any person or group to make or use the seal of the City of Merced, or any derivation, rendering, version, expression, logo, stamp or reproduction thereof, for any purpose other than for the official business of the City of Merced, its City Council, officers or departments, except upon approval of the City Council by resolution.

B. No person or group shall place any imitation of the City Seal, nor any derivation, rendering, version, expression, logo, stamp or reproduction thereof, on any written, printed or electronic material that is designed, intended or likely to confuse, deceive or mislead the public or cause the reader of such material to believe it to be an official city publication.

C. It shall be unlawful for any person or group to place the City Seal, or any derivation, rendering, version, expression, logo, stamp or reproduction thereof, on any written, printed or electronic material in favor of or against any ballot measure, or in favor of or against any candidate for public office.

1.08.040 Penalty.

A violation of this Chapter is a misdemeanor, punishable in accordance with Chapter 1.12 of this Code. At the discretion of the City, this Chapter may also be enforced by use of civil or administrative remedies.”

SECTION 2. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 3. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 4. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.

SUBJECT: Vacation #16-02 - Submitted by Robert Lattanzio for the Abandonment of an Old Sidewalk Easement at 3172 M Street

REPORT IN BRIEF

The City Council will consider the abandonment of a 14-foot wide sidewalk easement along the western property line at 3172 M Street.

RECOMMENDATION

City Council - Adopt a motion adopting **Resolution 2017-12**, a Resolution of the City Council of the City of Merced, California, ordering the vacation of a 14-foot wide sidewalk easement along the western property line of 3172 M Street, generally located on the east side of M Street, approximately 200 feet north of Fairfield Drive (Vacation #16-02).

ALTERNATIVES

1. Approve, as recommended by staff; or,
2. Approve, subject to modifications as conditioned by Council; or,
3. Deny based on specific findings; or,
4. Refer back to staff for reconsideration of specific items as requested by Council; or,
5. Continue to a future meeting (date and time to be specified in Council motion).

AUTHORITY

Part 3, Chapter 3 of the Streets and Highways Code of the State of California authorizes the City Council to vacate a right-of-way or easement. The vacation shall be made by adoption of a resolution pursuant to Section 8335 of the Code, and shall be recorded pursuant to Section 8336. The City of Merced Administrative Policies and Procedures No. A-6 provides direction to staff for processing vacation requests, and City Resolution 86080 establishes a policy concerning costs associated with the vacation.

CITY COUNCIL PRIORITIES

Not applicable.

DISCUSSION

In 2015, the applicant obtained Site Plan Review approval to develop a 15,237-square-foot office building on a vacant 1.58-acre parcel located at 3172 M Street (Attachment 2). This infill Project includes a new bus turnout and sidewalk configuration along M Street. The proposed sidewalk path

would be located west of an existing sidewalk easement (closer to M Street), but within the City's public right-of-way (Attachment 1). During the development review process, the City's Land Engineer determined that the City would have no need for the existing easement as the new sidewalk would be located away from the sidewalk easement, and he recommended that the Site Plan Review Committee adopt a condition of approval requiring the abandonment of the 14-foot-wide sidewalk easement. The applicant is requesting the vacation of this easement to comply with their Site Plan Review Permit and to obtain their Certificate of Occupancy (to occupy their new building). The new sidewalk path will not require another sidewalk easement, because it will be located within the public right-of-way.

History and Past Actions:

At the Planning Commission meeting of February 22, 2017, the Planning Commission reviewed the vacation for consistency with the City's General Plan and found, by unanimous vote of those present, that the proposed vacation does not conflict with any General Plan policies, text, or maps, and is, therefore, consistent with the General Plan.

On February 21, 2017, the City Council adopted a Resolution of Intention (Resolution #2017-08 - Attachment 3) and set March 20, 2017, as the date for the public hearing to consider Vacation #16-02. During the City Council Meeting, the City Council requested additional information about the proposed bus turnout. After the meeting, staff contacted The Bus Transit Manager, Richard Green, and he confirmed that he is currently working with the City's Engineering Department to install a bus shelter with a bench and trashcan at this location. Transit Manager Green noted that he will be attending the City Council Meeting on March 20, and that he will make himself available for questions from the City Council, if any. Prior to installing the bus shelter, the applicant will be applying for encroachment permits to ensure that both the bus shelter and the sidewalk path satisfy City Engineering Standards and Building Codes. The Engineering Department has noted that re-aligning the sidewalk with a straight configuration (instead of meandering configuration) would help with bus operations and allow ample space for the bus shelter. Other benefits with the realignment include reduced landscape maintenance and easier access to utilities.

Recommendation:

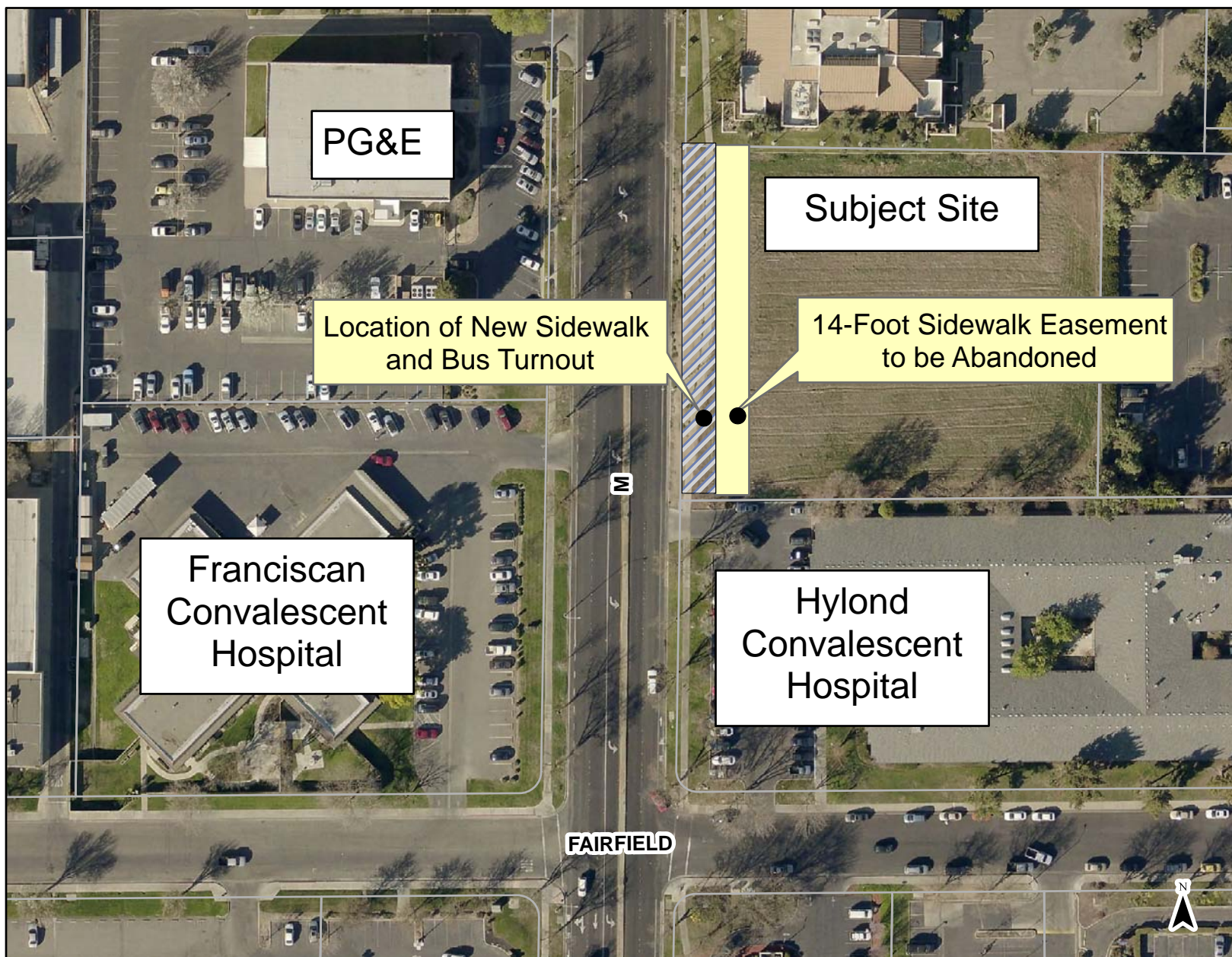
Staff is recommending the adoption of the Resolution at Attachment 4 to abandon the 14-foot wide sidewalk easement as described above.


VICINITY MAP

BACKGROUND

The impact of railroad noise on Central Merced has been an issue for many years. The City General Plan for 2030 indicates that the 26 daily trains passing through Merced on the Burlington Northern Santa Fe (BNSF) Railroad generate an average of 100 decibels of sound at 110 feet from the track. In response to an increase in train collisions, the federal government enacted regulations in 2005 that require the use of train horns at at-grade crossings as follows: 1) the horn must sound at 96 to 110 decibels; 2) must sound between 15 and 20 seconds before reaching a crossing; 3) if the train is exceeding 60 mph, it must be within a quarter mile before sounding the horn. The BNSF rail line runs along 24th Street through residential neighborhoods for approximately four miles. There are at-grade railroad crossings at 1) North Highway 59; 2) Bear Creek; 3) "U" Street; 4) "R" Street; 5) "M" Street; 6) Canal Street; 7) "K" Street and 8) Glen Avenue. At "G" Street and Yosemite Parkway the street and rail line are not at-grade, but separated, so no sounding of the train horn is required. In 2007, 11 of the 26 daily train trips occurred between 10:00 p.m. and 7:30 a.m. The number of train trips has increased to 40 per day in 2017. The Downtown Neighborhood Association (DNA) raised train noise in Central Merced as a quality of life issue in 2016. Reducing train noise would improve the living environment of Central Merced. Establishing Quiet Zone Crossings is conditioned on increasing crossing safety.

RAILROAD QUIET ZONES

The Federal Railroad Administration (FRA) allows an exemption from the regulations requiring trains to sound their horns at at-grade road crossings designated "quiet zone" crossings. Though the city is the driver of quiet zone establishment, crossing qualifications must be reviewed and approved by the railroad, the Public Utility Commission (PUC) and the FRA. Sometimes a quiet zone crossing can include: 1) a concrete median island over six inches high on both sides of the track extending a minimum of 100 feet from the crossing gate down the roadway (Exhibit 1); 2) four rather than two automated crossing gates with flashing light resulting in full closure of the crossing to cars (Exhibit 2); and 3) permanent closure of intersecting roadways within 60 feet of crossing gate and 4) creation of a quiet zone of minimum of half a mile in length.

THE PROCESS

The establishment of quiet zone crossings must be at the request of the city, or if a county road, the county. The city is responsible for funding the quiet zone crossing improvements if any are required which cost between \$200,000-\$600,000 at each crossing.

The city works with the BNSF railroad and applies to the FRA and PUC for approval of quiet zone status for those railroad crossings it chooses. The city issues a Notice of Intent (NOI) to create a quiet zone. The NOI intent to BNSF, FRA, Cal Trans (for North 59 crossing only) and the PUC. A 60 day comment period begins. Representative of the BNSF, FRA, PUC, Cal Trans and the city meet at each proposed quiet zone crossing to discuss existing conditions and possible changes. The affected agencies agree on what changes, if any, need to be made to make the crossing a quiet zone.

The city uses the FRA's Quiet Zone Calculator online to determine whether the Quiet Zone Risk Index of the proposed quiet zone is less than the Nationwide Significant Risk Threshold. If it is less, then the city can designate the crossing a quiet zone and apply for PUC approval. After approval quiet zone signs are installed at each crossing and the affected agencies are notified. No significant physical changes to the crossing are required.

If the Quiet Zone Calculator shows the proposed crossing exceeds the Significant Risk Threshold, the city must pay for installation of Supplementary Safety Measures (SSM's) such as median islands, crossing gates or wayside horns. Such SSM's are installed by the railroad or the city as appropriate. If the crossings are equipped with one or more SSM's the Quiet Zone can be established through city designation of the crossings installation of required signage per crossing, notification of the affected agencies and application for PUC approval. The City of Richmond, California has 14 quiet zone crossings, none of them have four crossing gates. This design, application and review process is specialized such that the city may want to contract with a consultant engineer experienced in establishing quiet zones to assist it.

WHICH CROSSINGS

Of the eight crossings of the BNSF railroad, "U" Street and "Glen Avenue" are the only ones that may not qualify as a quiet zone. This is because Santa Fe Avenue runs parallel and near the railroad tracks at the intersection making a raised median 100 feet long problematic for traffic flow and control. In such situations a permitted alternative is a "wayside horn" which are horns located at the crossing which sound when the train passes. Though loud, the noise is limited to 80 decibels within 400 feet of the crossing, compared to up to a quarter mile from the crossing experiencing a moving train horn blowing (Exhibits 3 & 4).

The city circulation pattern for north-south streets is to locate a major street every half a mile. These streets are North Highway 59, "R" Street, "M" Street, "G" Street, Glen Avenue and Parsons Avenue (planned.) If all eight existing crossing were changed to quiet zone crossings at \$400,000 each, 3.2 million is needed.

An alternative is to completely close street crossings of the railroad to avoid the cost of making quiet zone improvements. Streets which might be considered for closing are those that

duplicate the road access of other streets. "K" Street and Canal Street cross the railroad within two blocks of "M" Street crossing and are redundant of "M" Street in some ways. If "K" Street and Canal Street railroad crossings were closed at a cost of \$100,000, then the quiet zone crossings for six crossings plus two crossing closures is \$2.5 million, a reduction of \$700,000.

PARSONS AVENUE RAILROAD CROSSING

The City General Plan for 2030 Transportation and Circulation Element (page 4-38) states "The City has shown one additional rail crossing (Parsons Avenue/Santa Fe Railroad) on plans for many years. The PUC must approve any new railroad crossings for the city. Such approvals are rarely granted by the PUC, especially at-grade crossings and the crossings remain only on plans. As Merced continues to grow, the constraints imposed by a restricted number of railroad crossings will also increase." The reaction of the PUC to an additional railroad crossing at Parsons Avenue and BNSF Railroad is not known. The BNSF staff has indicated that it will consider supporting a new crossing at Parsons Avenue if two existing at-grade railroad crossings were eliminated. For the railroad, the goal is to increase safety and reduce liability. Fewer railroad crossings are safer than more crossings. A request by the city, with the support of BNSF, may be considered by the PUC for approval.

FUNDING QUIET ZONE IMPROVEMENTS

Quiet zones are for nearby residents an issue of noise reduction. For the railroad, the PUC and the general public quiet zones are an issue of increasing public safety and reducing hazards. Funding opportunities may exist in federal or state programs based on increasing safety or reducing noise. The cost of creating Merced's quiet zones will not be known until after the NOI, the meeting of the affected agencies at each crossing and the running of the FRA Quiet Zone Calculation for each crossing. The cost range is \$1.4 million to \$4.8 million for 7 to 8 crossings.

The areas benefitting significantly from noise reduction resulting from quiet zones is a function of distance from the noise source. For illustrative purposes if the area of significant benefit was set at half a mile, the benefit area is shown on Exhibit "5". In that area there are approximately 5,000 lots. If the cost of establishing quiet zones is \$3,000,000 then the cost per lot is \$600 or spread over five years \$10 per month approximately.

PROPOSAL

Based on the information above I recommend the council direct the city manager and city attorney to initiate a Notice of Intent to create quiet zone crossing designations for the eight existing BNSF railroad crossings with the FRA and BNSF Railroad, then report to council the required changes to these crossings and estimated costs to establish them as quiet zone crossings.

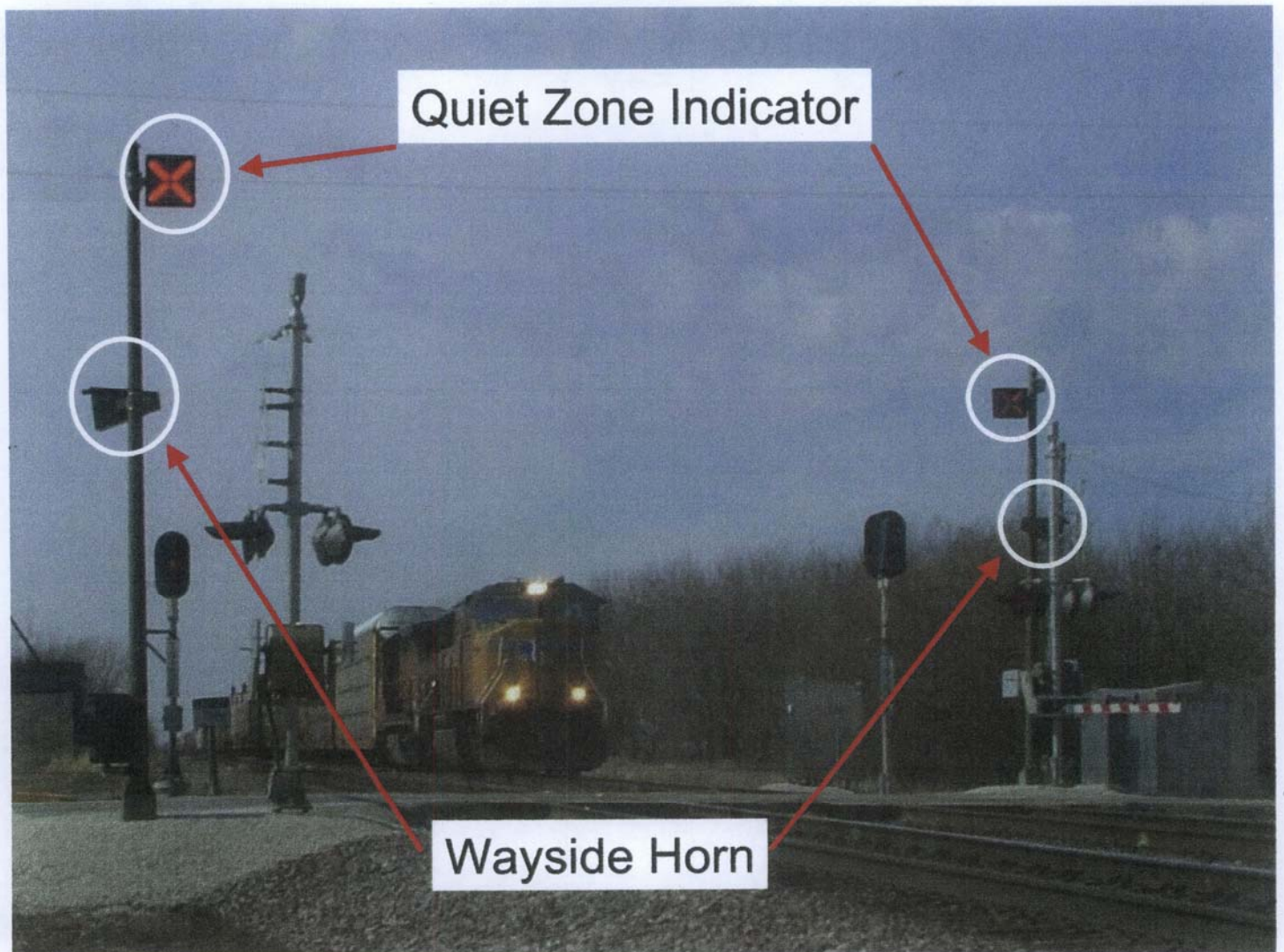

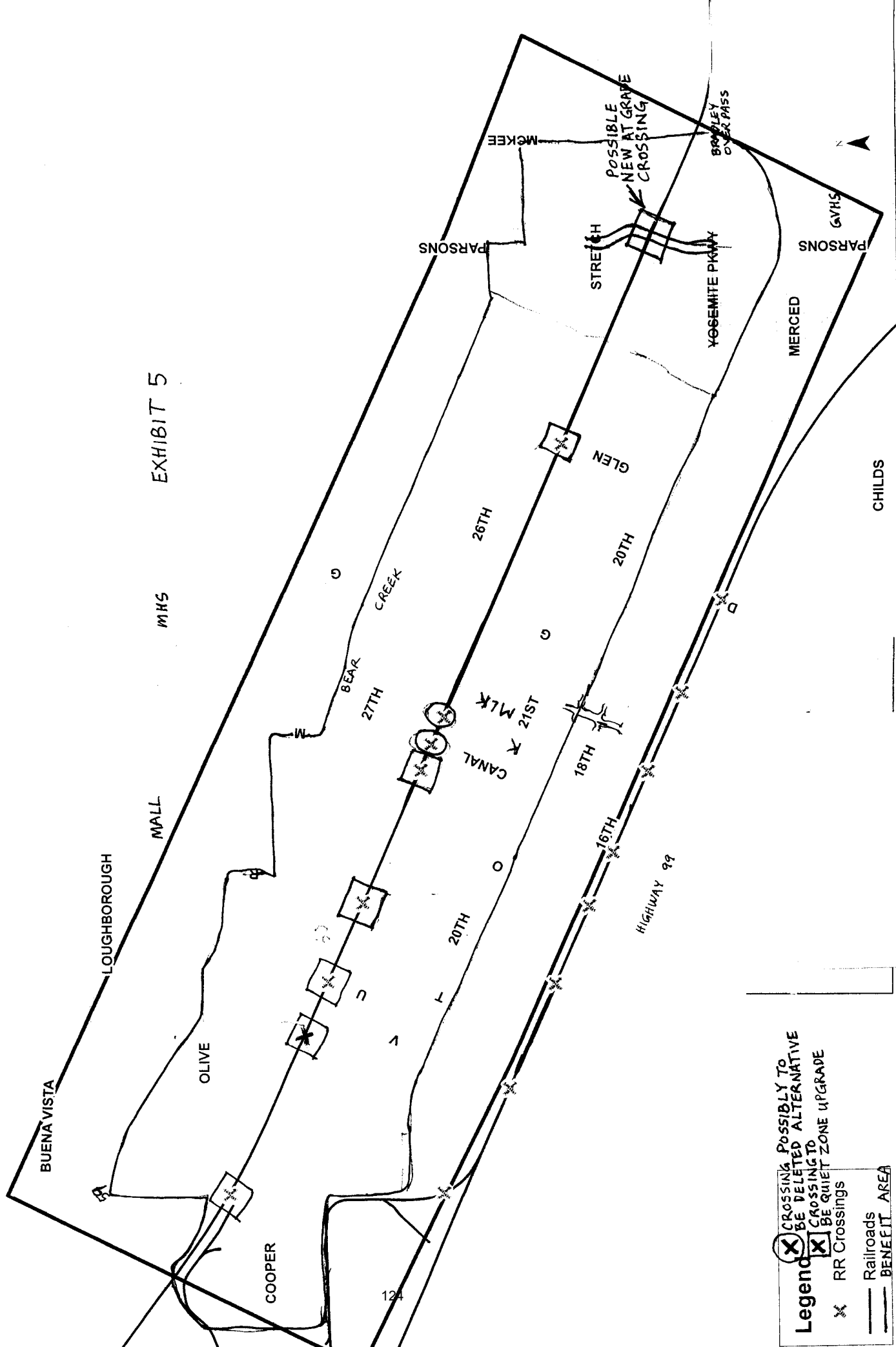




Red area is the 92dB sound contour
