Public Hearing to afford the interested public an opportunity to provide input on the content of the 2025-26 City Council, Public Financing and Economic Development Authority, Parking Authority, and Successor Agency to the Redevelopment Agency of the City of Merced Proposed Budget.

Finance Officer Venus RODRIGUEZ gave a slideshow presentation on the City Manager's proposed annual budget for fiscal year 2025-2026.

Council and Mrs. RODRIGUEZ discussed details of the changes to the Police Department's personnel, details of the arts funding, details of the Measure C funding, the potential of moving positions from the Fire and Police Departments to be funded by Measure C, details of CalPERS, details of Trust 115, details of the Public Works enterprise fund summary, details of the rate study, and details of the new Measure C fund.

Mayor SERRATTO opened the Public Hearing at 7:31 PM.

Eddie RODRIGUEZ, Merced - spoke on the open-call Request for Proposal (RFP) for local artists and encouraged a contribution to the arts budget to help the community.

Hugo CASTRO-PONCE, Merced - spoke in opposition of amending the housing policy to fund the deficit, shared support for re-prioritizing affordable housing, and implementing a Rental Registry or Inspection Program in the City.

Ana QUINTANA-CEJA, Merced - spoke in support of investing in a Rental Registry/Inspection Program, a Home Rehabilitation Program, Homebuyer Assistance Programs, South Merced projects, and suggested re-allocating a percentage of Measure Y to the Parks and Recreation Department.

Maria CALDERON, Merced - shared concerns of the water, sewage, contaminated wells, and the roads on South P Street in South Merced.

Robert RODRIGUEZ, Merced - shared details of his living situation and spoke on the management in his apartment complex.

Andrea URIBE, Merced - spoke on investing in road and bicycle lane improvements, an updated South Merced Plan, and projects in South Merced.

Ashley Marie SUAREZ, Merced - urged the City to engage more with the community for input on the proposed annual budget, encouraged the City to establish a Rental Registry/Inspection Program, to invest in mobile home parks, and expand the First-Time Homebuyer Program.

Curtis THOMAS, Merced - spoke on the funding being used to create the General Plan Amendment of the City and requested the City publish a value-per-acre analysis.

Colton DENNIS, Merced - advocated for the Parks and Recreation Department and the Arts and Culture Advisory Commission to receive funding in the annual budget.

Mayor SERRATTO closed the Public Hearing at 7:57 PM.

Council, Mrs. RODRIGUEZ, Fire Chief Casey WILSON, Chief of Police Steven STANFIELD, and City Manager Scott MCBRIDE discussed withholding funding from the new Measure C Fund, potentially fully funding public safety positions, defining public safety in the City, funding what community members are requesting, details of the SAFER Grant staffing funds, and allocating funding from the General Plan to the Measure C Fund. They also discussed details of applying for the economic hardship waiver for the SAFER Grant, details of the proposed budget, details of the School Resource Officers funded by the Police Department, details of grant opportunities for the Police Department, details of both Measure C funding sources, management positions in the City, and details of the Reserve Fund.

A motion was made by Council Member Smith, seconded by Council Member Dupont, to use Measure C to fund the one firefighter position that is proposed to be frozen. The motion carried by the following vote:
