Interim Fire Chief Casey WILSON and City Manager Scott MCBRIDE gave a slideshow presentation on the Merced County Aid Agreement update.

Council, City Attorney Craig CORNWELL, Mr. WILSON, and Mr. MCBRIDE discussed details of the recommendation, the difference between Emergency Medical Services (EMS) calls and fire calls, details of the new squad vehicle, updates on the Computer Aided Dispatch (CAD) system, details of the partnership with Merced County, and details of firefighter safety. They also discussed the projected response times, details of the additional staffing, details of the cost-sharing listed in the Memorandum of Understanding (MOU), conversations with UC Merced regarding the MOU, the Term of the MOU, details of the SAFER grant, the emergency responses, the benefits of the MOU, how calls will come through outside city limits, and details of Station 53's response.

Merced County Josh PEDROZO - shared details of the MOU, the cost-sharing between the County and the City, and the collaboration with all agencies to provide the best service for the citizens.

Mike MURPHY, Merced - requested Council to approve the discussions with County and the MOU and shared his safety concerns as a county resident impacted by the issue.

Dr. Steve TIETJEN, Merced - shared safety concerns as a county resident and spoke on the need of UC Merced collaborating with all agencies.

Council and Mr. MCBRIDE discussed the decision that would benefit all citizens, the impacts on the Merced Fire Department, and the continuation to collaborate with Merced County.
