## F. REPORTS

# F.1 SUBJECT: Active Transportation Plan (ATP) Update

#### REPORT IN BRIEF

Update Commission on the adoption of the ATP. This does not require action by the Commission at this meeting.

Principal Planner LAN updated the Bicycle and Pedestrian Advisory Commission on the adoption of Merced County Regional Active Transportation Plan by the City Council on June 3, 2024 and that the BPAC's concerns about the connections to and from the HSR station were expressed to the Council before adoption. Principal Planner LAN told the Commission that the final adopted Plan was sent to the HSR design team for reference and that they have been using the plan as a basis for their active transportation onsite and linkage design. Explained that the Engineering and Planning will try to work together to overlay the ATP with CIP projects and make our AT system a little safer a project at a time.

# F.2 SUBJECT: Engineering Report

#### REPORT IN BRIEF

Staff will provide informational items to the Commission regarding Engineering, current projects, or other items not requiring action by the Commission at this meeting.

Interim City Engineer MADDOX gave an update of the projects related to Active Transportation and Rail. The Commission asked how projects get addressed and prioritized. City staff responded with the different ways that projects are prioritized and placed in queue and funded. Staff let the Commission know about the CMAQ Community Meeting to be held Tuesday, September 10, 2024, from 6:00-8:00 PM.

Update Commission on High-Speed Rail design and the proposed surrounding infrastructure.

Principal Planner LAN reiterated that the HSR Station Design has considered the newly adopted Merced Active Transportation Plan. Staff discussed the potential Viaduct Class 1 greenway and links to the station from South and North Merced. Commissioners discussed concerns about the impact of being an end-of-the-line station on air quality and if there are mitigations adopted to address it.

She offered to give other support if it was requested after the update.

Ex-Officio Member THOMAS requested an item on a future agenda to evaluate the use of speed tables at road crossings where there are schools.

Commissioner MELOY would like to add an item to discuss memorializing the 50th Anniversary of the Bear Creek Bike and Pedestrian Trail (Michael O'Sullivan Trail). An update on the restoration of the trail and it's restoration funding as well.

Ex-Officio Member THOMAS requested discussing improving bicycle parking in the City.

Principal Planner LAN suggested that she will bring HSR to a future meeting to discuss the Active Transportation elements of the Station design. She also suggested that the December meeting may be cancelled and that the Commission will need to elect a chair and vice-chair at the October meeting.
