WHEREAS, City and Vendor have previously entered into an Agreement for Supplies and Services ("Agreement") dated May 17, 2021, and a First Amendment dated July 1, 2022; and,

WHEREAS, City and Vendor desire to amend said Agreement to exercise the second option to renew the Agreement.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 26, "SECOND OPTION TO RENEW," is hereby added to the Agreement to read as follows:

"SECTION 26. SECOND OPTION TO RENEW. The City and Consultant desire to exercise the option to renew the Agreement for one (1) additional year pursuant to Section 1, 'Parties and Term' of the Agreement. The term of this second renewal shall be from July 1, 2023 to June 30, 2024."

2. Section 27, "COMPENSATION DURING SECOND RENEWAL TERM," is hereby added to the Agreement to read as follows:

"SECTION 27. COMPENSATION DURING SECOND RENEWAL TERM. City shall pay Consultant the not to exceed sum of total of One Hundred Fifty Thousand Dollars (\$150,000.00) for supply and delivery of sodium fluoride through Fiscal Year 2023-2024 at the amended unit price listed on Exhibit 1."

3. Except as herein amended, the Agreement dated May 17, 2021, and First Amendment dated July 1, 2022, shall remain in full force and effect.
