F.2 SUBJECT: REQUEST #25-24 Requesting Speed Bump To Be Installed On Michelle Drive

REPORT IN BRIEF

Citizen shares concern for safety due to vehicles traveling at high speeds westbound on Arrow Wood Drive, turning southbound on Michelle Drive. Citizen states they have to cross Michelle Drive to collect their mail and are afraid of being hit. Citizen is requesting a speed bump be installed on Michelle Drive to slow down motorists.

Member HAYGOOD reported that there are no accidents reported for the area of this request and stated traffic enforcement may be able to assist with speeding. Member OLMOS stated striping on the streets are thermoplastic and visible. Chair JORDAN reminded the public about traffic calming procedures.

Member OLMOS asked about the installation of a speed limit sign for the subdivision, and Chair JORDAN stated the Engineering Department is overseeing a citywide speed study and will see if the street in question can have a speed limit sign added.
