## THIRD AMENDMENT TO SERVICES AGREEMENT

THIS THIRD AMENDMENT TO AGREEMENT is made and entered into this 1st day of July, 2025, by and between the City of Merced, a California Charter Municipal Corporation ("City"), and California Public Policy Group, a California Corporation, ("Contractor").

WHEREAS, City is undertaking a project for consultant services to provide federal and state representation for legislative advocacy; and,

WHEREAS, City and Contractor have previously entered into a Services Agreement ("Agreement") dated December 19, 2022, wherein the total not to exceed compensation amount was \$180,000; and,

WHEREAS, City and Contractor entered into a First Amendment to Agreement dated June 28, 2023, increasing the compensation amount by \$3,000 to make the total not to exceed compensation amount of \$183,000 for the Agreement; and,

WHEREAS, City and Contractor have previously entered into a Second Amendment to Agreement dated September 3, 2024 to provide for a name change of the Contractor; and,

WHEREAS, City and Contractor desire to amend said Agreement to extend the term of the agreement in connection with said project; and,

WHEREAS, City and Contractor desire to amend said Agreement to provide for \$18,000 in additional compensation to continue legislative advocacy services; and,

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 3, "TERM OF AGREEMENT," is hereby amended to the Agreement to read as follows:

The term of this Agreement shall commence on December 19, 2022 and shall end on September 30, 2025.

2. Section 23, "ADDITIONAL COMPENSATION," is hereby added to the Agreement to read as follows:

City shall pay to Contractor the not to exceed additional sum of Eighteen Thousand Dollars (\$18,000) for work performed under the Agreement in accordance with the rates set forth in the Agreement dated December 19, 2022, bringing the total compensation amount of the agreement to \$201,000.

3. Except as herein amended, the Agreement dated December 19, 2022, shall remain in full force and effect.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Merced (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## Getting paper copies
