# SECOND AMENDMENT TO SERVICES AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT is made and entered into this 1st day of July, 2025, by and between the City of Merced, a California Charter Municipal Corporation ("City"), and California Public Policy Group, a California Corporation, ("Contractor").

WHEREAS, City is undertaking a project for consultant services to provide grant writing services; and,

WHEREAS, City and Contractor have previously entered into a Services Agreement ("Agreement") dated March 1, 2024, wherein the total not to exceed compensation amount was \$56,000; and,

WHEREAS, City and Contractor have previously entered into a First Amendment to Agreement dated September 3, 2024 to provide for a name change of the Contractor; and,

WHEREAS, City and Contractor desire to amend said Agreement to extend the term of the agreement in connection with said project; and,

WHEREAS, City and Contractor desire to amend said Agreement to provide for \$10,500 in additional compensation to continue grant writing services; and,

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 3, "TERM OF AGREEMENT," is hereby amended to the Agreement to read as follows:

The term of this Agreement shall commence on March 1, 2024 and shall end on September 30, 2025.

2. Section 23, "ADDITIONAL COMPENSATION," is hereby added to the Agreement to read as follows:

City shall pay to Contractor the not to exceed additional sum of Ten Thousand Five Hundred Dollars (\$10,500) for work performed under the Agreement in accordance with the rates set forth in the Agreement dated March 1, 2024, bringing the total compensation amount of the agreement to \$66,500.

3. Except as herein amended, the Agreement dated March 1, 2024, shall remain in full force and effect.

### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Merced (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us.
