

THIRD AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS THIRD AMENDMENT TO AGREEMENT is made and entered into this ____ day of _____, 2024, by and between the City of Merced, a California Charter Municipal Corporation, whose address of record is 678 West 18th Street, Merced, California 95340, (hereinafter referred to as “City”) and Northstar Engineering Group, Inc., a California Corporation, whose address of record is 620 12th Street, Modesto California 95354, (hereinafter referred to as “Consultant”).

WHEREAS, City is undertaking a project to provide on-call civil engineering and surveying services; and,

WHEREAS, City and Consultant have previously entered into an Agreement for Professional Services (“Agreement”) dated September 7, 2021; and,

WHEREAS, City and Consultant have previously amended said Agreement dated October 3, 2022, to provide additional compensation in connection with said project; and,

WHEREAS, City and Consultant have previously amended said Agreement dated November 20, 2023, to provide for an additional term in connection with said project; and,

WHEREAS, City and Consultant desire to amend said Agreement again to provide for a final additional term in connection with said project.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 25, “SECOND OPTION TO RENEW,” is hereby added to the Agreement to read as follows:

The City and Consultant desire to exercise the option to renew the Agreement for one (1) additional year pursuant to Section 3, ‘Term of Agreement’ of the Agreement. The term of this second renewal shall be from September 7, 2024 through September 6, 2025.

2. Except as herein amended, the Agreement dated September 7, 2021, the Amendment dated October 3, 2022, and the Amendment dated November 20, 2023, shall remain in full force and effect.
