

**SECOND AMENDMENT TO AGREEMENT FOR
PROFESSIONAL SERVICES**

THIS SECOND AMENDMENT TO AGREEMENT is made and entered into this 17th day of May, 2023, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Goldman, Magdalin & Krikes, LLP, whose address of record is 735 Tank Farm Road, Suite 200, San Luis Obispo, California 93401, (“Attorney”).

WHEREAS, City and Attorney have previously entered into an Agreement for Professional Services (“Agreement”) dated November 4, 2019, and a First Amendment to Agreement dated April 28, 2021; and,

WHEREAS, City and Attorney desire to amend said Agreement to provide for a fee increase for Partner services.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 23, “COMPENSATION ADJUSTMENT,” is hereby added to the Agreement to read as follows:

“SECTION 23. COMPENSATION ADJUSTMENT. As of the effective date of this First Amendment, City shall pay Attorney for actual services rendered under this Agreement in accordance with the fee schedule set forth below. The Attorney agrees to provide all services required under the Scope of Services in Exhibit ‘A’ within the compensation amount set forth below

Partner	\$180.00/hour
Associate	\$165.00/hour
Lien Specialist	\$115.00/hour
Paralegal/ Administrative Assistant	\$ 90.00/hour

2. Except as herein amended, the Agreement dated November 4, 2019, and First Amendment dated April 28, 2021, shall remain in full force and effect.


