Money is being allocated for safe bike routes; however, the creation of new Class I bike paths are being put on a low priority list. Meetings regarding the city's bike system have low attendance, or sometimes they are canceled.

No one seems to give a damn.

We do have some nice scenic bike paths, but they were built years ago, and need to be upgraded and /or repaired.
