

**THIRD AMENDMENT TO AGREEMENT
FOR PROFESSIONAL SERVICES**

THIS THIRD AMENDMENT TO AGREEMENT is made and entered into this 2nd day of February, 2024, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Hanson Bridgett LLP whose address of record is 425 Market Street, 26th Floor, San Francisco, California 94105 (hereinafter referred to as “Attorney”).

WHEREAS, City and Attorney previously entered into an Agreement for Professional Services (“Agreement”) dated July 3, 2023, wherein the total not to exceed compensation amount was \$36,000.00;

WHEREAS, City and Attorney entered into a First Amendment to Agreement dated September 18, 2023, increasing the compensation amount by \$64,000.00 to make the total not to exceed compensation amount \$100,000.00 for the Agreement;

WHEREAS, City and Attorney entered into a Second Amendment dated March 19, 2024, increasing the compensation amount by \$20,000.00 to make the total not to exceed compensation amount \$120,000.00 for the Agreement; and,

WHEREAS, the parties desire to amend the Agreement to add additional compensation and exercise the first option to renew the Agreement for one additional one-year term.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 23, “ADDITIONAL COMPENSATION,” is hereby added to the Agreement to read as follows:

“SECTION 23. ADDITIONAL COMPENSATION.
City shall pay to Firm the not to exceed additional sum of One Hundred Fifty Thousand Dollars (\$150,000.00) in accordance with the rates set forth in the Agreement dated July 3, 2023.”

2. Section 24, "FIRST OPTION TO RENEW," is hereby added to the Agreement to read as follows:

"SECTION 24. FIRST OPTION TO RENEW. The City and Attorney desire to exercise the first option to renew the Agreement for one (1) additional year pursuant to Section 3, 'Term of Agreement'. The term of this first option to renewal shall be from July 1, 2024 to June 30, 2025."


