

**FIRST AMENDMENT TO SUPPLIES AND SERVICES AGREEMENT**

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this 9 day of MAY, 2022, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Interstate Truck Center, LLC, a California Limited Liability Company, whose address of record is P.O. Box 6463, Stockton, California 95206, (“Vendor”).

WHEREAS, City requires the supply and delivery of various vehicle parts and vehicle repair/parts installation services; and,

WHEREAS, City and Vendor have previously entered into an Agreement for Professional Services (“Agreement”) dated January 3, 2022; and,

WHEREAS, City and Vendor desire to amend said Agreement to provide for additional purchases and services.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 23, “ADDITIONAL COMPENSATION,” is hereby added to the Agreement to read as follows:

“SECTION 23. ADDITIONAL COMPENSATION.  
City shall pay to Vendor the not to exceed additional sum of Fifty Thousand Dollars (\$50,000.00) for the additional supplies and services in accordance with the quoted unit/item cost or labor rate.”

2. Except as herein amended, the Agreement dated January 3, 2022, shall remain in full force and effect.
