F.1 **SUBJECT:** Engineering Report

REPORT IN BRIEF

Staff will provide informational items to the Commission regarding Engineering, current projects, or other items not requiring action by the Commission at this meeting.

Interim City Engineer WEGLEY provided a presentation about the City's current engineering project list. He discussed the process for projects being added onto this list. Interim City Engineer WEGLEY categorized projects by funding mechanism such as funding from Measure "C", Measure "V", and grants.

F.2 **SUBJECT:** Status of City of Merced Active Transportation Plan

REPORT IN BRIEF

Staff will provide a report and answer questions regarding the status of the City's Active Transportation Plan.

Associate Planner MENDOZA-GONZALEZ provided a presentation regarding the status of the City's Active Transportation Plan. Associate Planner MENDOZA-GONZALEZ noted that this plan needs to be updated to the Planning Division's website. The Planning Division currently has the older version of this plan, which is titled City of Merced Bicycle Transportation Plan (adopted in 2013). Staff is in the process of updating the Planning Division's webpage to include the City's Active Transportation Plan, which was adopted in 2019. Staff noted that these long-range plans are generally updated every 10 to 15 years depending on funding/grant availability, and staffing levels. MCAG is currently working on a County-wide Active Transportation Plan which will give the BPAC an opportunity to be involved in the planning of bicycle and pedestrian facilities

within Merced and other parts of the County.

The commission had questions about how public improvement projects are selected.

Interim City Engineer WEGLEY noted that the City's General Plan Circulation Element and the Active Transportation Plan are the drivers for the projects selected. These projects are added to the City's capital improvement project list annually.

SUBJECT: Process for Installation of Bicycle Racks

REPORT IN BRIEF

Staff will provide a report and answer questions regarding the process for installing bicycle racks for private and public projects.
