



## 2<sup>nd</sup> Substantial Amendment – 2023 Annual Action Plan

April 2024

### Summary of Changes to Projects and Amendment Details

#### Introduction and Reason for Amendment:

Through a second amendment to the 2023 Annual Action Plan (2023 AAP) for Program Year 2023-24, the City of Merced intends to make changes to previously approved U.S Department of Housing and Urban Development (HUD) Community Development Block Grant (CDBG) projects and to correct previously stated CDBG financial resource calculations.

This summary has been prepared to illustrate and explain what items in the current amended AAP will be further amended, added, or deleted. The 2023 AAP was first amended in January 2024, to expedite expenditure of excess CDBG funds. The primary need for a second amendment is due to the discovery of unintended miscalculations of CDBG financial resource figures as the initial amendment was being readied for its January City Council approval. Given its urgent nature, Council and HUD approved the first amendment, conditioned with the directive to City staff to immediately start a second amendment process that would correct the errors, which now necessitates eliminating and/or postponing additional projects in order to balance the program year budget. Council and subsequent HUD approval of this second amendment will allow City staff to then close out the 2023-24 Program Year with accurate project lists and financial calculations.

### **Other changes to the 2023-24 Annual Action Plan in this Second Substantial Amendment:**

1. Increase in Program Income: more program income has continued to be received at higher amounts than originally anticipated (original estimate: \$93,000). This second amendment will specifically include and direct an additional \$27,225 of this unanticipated program income towards Project #15 (HSG - CDBG/HOME: Affordable Rental Housing - Land Acquisition and Construction (23/26). Total program income of \$147,320 now received in 2023-24 and added to the previously amended CDBG Expected Resources.
2. As a result of the deletion of 2022 Project #7 noted in the table above, the previously amended 2023 Carryover Funds is increased by \$275,000, which will then increase the previously amended 2023 CDBG Expected Resources by the same amount.
3. As a result of project changes/deletions, the following adjustments to the previously amended 2023 CDBG Annual Goals and Objectives (Section AP-20 in AAP) are necessary: a) Goal 1A – decrease by \$657,623; b) Goal 2A – increase by \$1,997; c) Goal 2B – decrease by \$159,173; d) Goal 3A – increase by \$2,377; e) Goal 4A – increase by \$422.
4. Minor text amendments and other corrections related to these adjustments will be made to sections where these projects and goals are mentioned.
