

RESOLUTION NO. 2023-_____**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA, TO
ADHERE TO THE MERCED COUNTY
REGIONAL WASTE MANAGEMENT
AUTHORITY (MCRWMA) FLOW CONTROL
POLICY**

WHEREAS, the Merced County Regional Waste Management Authority (MCRWMA) is a Joint Powers agency created by the six incorporated cities in Merced County and the County of Merced, pursuant to Government Code Sections 6500 et. Seq.; and,

WHEREAS, pursuant to the Department of Resources Recycling and Recovery (CalRecycle) and California Code of Regulation Title 14, Division 7, Chapter 12: Short-lived Climate Pollutants (SLCP): Organic Waste Reductions (SB1383), that requires local agencies to divert organic material from landfills; and,

WHEREAS, the local government agencies in Merced County have requested MCRWMA to provide services to aid in meeting SB1383 requirements at no cost to MCRWMA; and,

WHEREAS, MCRWMA engaged HF&H Consultants to assist in managing the RFP process to determine who will provide the best, most affordable service to participating agencies; and,

WHEREAS, staff from multiple agencies within the jurisdiction of MCRWMA participated in the committee evaluating submitted qualifying proposals; and,

WHEREAS, the evaluation committee selected a proposal to assume operation of all organic processing at the MCRWMA Highway 59 Landfill for the Merced County Association of Governments governing board consideration; and,

WHEREAS, the proposed facility will need a minimum amount of organic material to operate at the proposed pricing; and,

WHEREAS, MCRWMA currently has a Flow Control Policy in place per Resolution No. 2021/02-18-01 (FLOW CONTROL POLICY).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MERCED DOES HEREBY RESOLVE, DETERMINE, FIND, AND ORDER AS FOLLOWS:

SECTION 1. The City Council agrees to continue to follow MCRWMA's Flow Control Policy.
