### **SECOND AMENDMENT TO CONTAINER PURCHASE AGREEMENT**

THIS SECOND AMENDMENT TO AGREEMENT is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2025, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Schaefer Plastics North America, a North Carolina Limited Liability Company, (“Vendor”).

WHEREAS, City is in need of purchasing solid waste collection containers; and,

WHEREAS, Vendor, under the name of Schaefer Systems International, Inc. and the City previously entered into a Container Purchase Agreement (“Agreement”) dated September 21, 2020, and a First Amendment dated September 7, 2021; and,

WHEREAS, City and Vendor desire to amend said Agreement to provide for the name change of the Vendor and to exercise the first option to renew.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. The Agreement dated September 21, 2020 shall be amended to reflect the name change of the Vendor to Schaefer Plastics North America, LLC.

2. Section 19, “FIRST OPTION TO RENEW,” is hereby added to the Agreement to read as follows:

The City and Vendor desire to exercise the option to renew the Agreement for one (1) additional year pursuant to Section 1, ‘Term’ of the Agreement. The term of this first renewal shall be from September 21, 2025 through September 20, 2026.

3. All references to Exhibit 1 shall be changed to the updated Exhibit 1, attached hereto.

4. Except as herein amended, the Agreement dated September 21, 2020, and First Amendment dated September 7, 2021, shall remain in full force and effect.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Merced (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
