Member LAN shared that General Plan update has started.

SUBJECT: CONTINUED REQUEST #24-44 Requesting Painted Bike Lanes And 4 Way Stop Signs At The Intersection Of 15th Street And D Street And Before The S-99 Ramp Along 16th Street.

REPORT IN BRIEF

Citizen is concerned about the bicyclist and vehicle traffic traveling on both 15th Street and D Street and 16th Street towards the S-99 on ramp. Citizen explained that he has witnessed several near-misses of pedestrian vs. vehicle accidents. Adding a four way stop at both intersections and painted bike lanes could improve bicyclist and pedestrian safety.

Citizen came to share consistent concern for this location and is in support of finding ways for more safety.

Members agreed to deny the request as some of this is out of the city's jurisdiction and is in Caltrans right of way. Members can reach out to Caltrans to let them know the concern and relay contact information to the requestor.

SUBJECT: CONTINUED REQUEST #24-50 Requesting A Four Way Stop At The Intersection Of 18th Street And O Street.

REPORT IN BRIEF

Citizen shares how there have been several accidents at this intersection in the past and it continues to be dangerous due to near-miss vehicle accidents that happen almost daily. Drivers tend to exceed the 30 mph speed limit. By adding additional stop signs and making this a four way stop, it could promote safety for all citizens in the area.

Members determined this location does not meet warrants for the request.

Citizen mentions that the middle section of red paint along the curb at 1402 E 21st Street should be removed due to miscommunication (please see the attached photos for reference). This portion of red paint is not only not needed, but also takes away from parking spaces that residents could use.

Member WILSON stated that this request came from the fire department and explained the background on the request. The fire department is looking to support residential parking by removing the red paint along the curb that was mistakenly painted.

Member OLMOS mentioned how there were no measurements listed for the red painted curb and suggested that the curb painting be measured once this area is updated.

SUBJECT: REQUEST #25-06 Requesting A Handicapped Parking Space in Front of Home at 2980 Masterson Lane.

REPORT IN BRIEF

Citizen states that she is a handicapped individual who utilizes the parking space in front of her house, as it is the quickest route for her to carry items into her home. She spoke with her neighbor and explained her need for the parking space; however it seems to still be used for other neighbors vehicles. There are 18 marked parking spaces for residents to use aside from the one in front of the citizen's home.

Citizen addressed her concern to the committee, further emphasizing the need for a handicapped parking space in front of her home.

Members discussed that they did not have the power of enforcement, given that this location is within an HOA neighborhood and is on a private roadway.

Citizen shares concern for children safety due to vehicles traveling at high speeds on all the streets in the Devonwood Development. Adding speed bumps could caution drivers to slow down.

Citizen mentioned that this item could be cancelled based upon the last motion and discussion that the City has no jurisdiction in the HOA neighborhood.

Members agreed to deny based on this area not being within the city's jurisdiction.

SUBJECT: REQUEST #25-08 Requesting To Restripe Approximately 1,000 Linear Feet Of Roadway On Kibby Road.

REPORT IN BRIEF

Citizen expresses concern for the safety of all members of the public with oversize trucks (big rigs) parking alongside the entrance of the PG&E location here on Childs Avenue. Citizen continues to explain how PG&E has made efforts to mitigate the safety risks of all since 2018, yet the no parking signage and red curbing have not been enforceable by the local police department. Despite additional efforts to keep these areas clear, all fixed objects that PG&E has placed in the roadway have been physically removed or carelessly ran over. Citizen recommends restriping approximately 1,000 linear feet of roadway on Kibby Road to eliminate the shoulder in front of their property from the corner of East Childs Avenue to the barricade on the north end of their property. Lastly, to support of this recommendation, citizen notes that traffic engineers will notice that the lane can naturally and gradually transition back to the existing striping on the north end of the property, and there may be adequate room to allow for a dedicated lane to turn east on Childs Avenue on the south end of the property.

Citizen shared that this has been a hazard for many years and they have tried several different ways to mitigate this issue, all of which have been unsuccessful. She stated she is an advocate for a solution on this concern further adding that PG&E would be willing to discuss the terms of splitting

the cost.

Members shared support and understanding of the request, however safety and funding remained a concern, so they agreed to having a future discussion with PG&E to talk about these matters and determine how to move forward.

A motion was made by Member McKinnon, seconded by Member Olmos, that this agenda item be approved with the contingency of a meeting with PG&E and McLane to discuss the financial terms of this request. The motion carried by a unanimous vote.

SUBJECT: REQUEST #25-09 Requesting Red Curbing Near Ada Givens Elementary School.

REPORT IN BRIEF

Sergeant McKinnon is requesting red curbing in front of 2860 Green St and 2875 Green St, or no parking from 7am until 4pm.

The superintendent of Merced City Schools shared her support for the requests sent in by Member McKinnon that would work to foster a safer environment for all vehicles and pedestrians near these schools.

Member MCKINNON stated that the residents whose homes are in front of this proposed red curbing are in support of the modification due to vehicles frequently blocking their driveways when dropping their children off at school.

Member LAN requested that there be a document with written support from the residents and to confirm that this change will not negatively affect them.

REPORT IN BRIEF

Citizen shares concerns explaining how despite there being 10 traffic signs and one marked pedestrian crosswalk at the intersection of V Street and W 11th Street, motorists fail to yield to pedestrians in the crosswalk. In addition to that, motorists on W 11th Street continue to launch across V Street building up speed to X Street/West Avenue.

Citizen addressed the members of the committee to display the efforts she takes to keep students safe in the crosswalks and added how drivers disregard her and her signage and put everyone's safety at risk. She also shared letters written by fellow concerned crossing guards for this same area.

Another citizen shared her concern for the high volume of traffic in the area and the speeds in which they travel near the school.

Members agreed to add this item to the other agenda items that were bundled together.

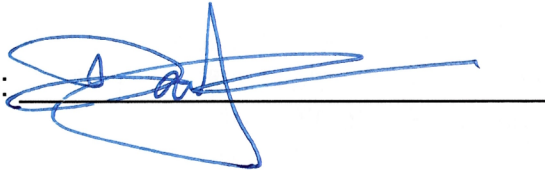
