J.2. **SUBJECT:** Appeal of the Planning Commission's Approval of Commercial Cannabis Business Permit (CCBP) #22-02R for Retail Cannabis at 1111 Motel Drive by Edwin Kainth

#### **REPORT IN BRIEF**

Edwin Kainth has appealed the Planning Commission's approval of Commercial Cannabis Business Permit #22-02R (Culture Merced Dispensary) for a retail cannabis facility at 1111 Motel Drive.

## RECOMMENDATION

City Council - Adopt a motion:

- A. Granting or denying the appeal of Edwin Kainth; and,
- B. Providing direction to staff regarding findings to grant or deny appeal, with or without prejudice.

Development Services Technician Stephani DAVIS gave a slideshow presentation on the appeal of the Planning Commission's approval of the Commercial Cannabis Business Permit (CCBP) #22-02R for retail cannabis.

Clerk's Note: Council Member DEANDA recused himself at the request of Acting City Attorney Travis LINDSEY, Council Member DEANDA was a member of the Planning Commission when the matter was heard.

Clerk's Note: All Council Members disclosed conversations with organizations involved and any additional information.

Mayor SERRATTO opened the Public Hearing at 7:36 PM.

**Clerk's Note:** The following comments were received via voicemail.

Gloria LENCIONI, Merced - spoke in opposition of opening a cannabis dispensary in her neighborhood.

Samil, Merced - spoke in support of the appeal and the opposition of the cannabis dispensary on Motel Drive.

Teresa BOND, Merced - spoke in opposition of opening the cannabis business in her neighborhood.

Grant QUINN, Merced - spoke in opposition of the cannabis dispensary due to kids being on the street.

**Clerk's Note:** The following speakers appeared in person.

Jim SANDERS, Merced - asked Council for the amount of time he is allowed to speak.

Development Services Director Scott MCBRIDE explained that Jim SANDERS currently stands as the Leader of Opposition and explained the structure of the Planning Commission for the amount of minutes the Leader of Opposition and Appellant receive.

Mayor SERRATTO stated the Leader of Opposition and Appellant will have 15 minutes in total, per Acting City Attorney Travis LINDSEY.

Jim SANDERS, Leader of Opposition, Merced - gave a slide show presentation on the Appeal of the Planning Commission's approval of the Commercial Cannabis Business Permit #22-02R on Motel Drive.

Edwin KAINTH, Appellant, Merced - spoke in opposition of the Planning Commission's approval of the Commercial Cannabis Business Permit #22-02R on Motel Drive, questioned the lack of a traffic study in the area, and explained the lack of revenue the Motel would bring if the dispensary is approved.

Elias PATINO, Merced - spoke in opposition of the dispensary being built in this location due to the amount of kids in the area that go for walks, play, and lack of lighting.

Daniel PEREZ, Merced - spoke against the dispensary opening due to the amount of kids that walk to school.

Avtar SINGH, Merced - spoke in opposition due to the influence of cannabis on kids.

Jared Paladin RUSCOE, Speaker for Property Owners, Merced - spoke on the funds spent on maintaining the building since closing.

Arvin KAINTH, Merced - spoke on the conditions of Motel Drive and the parking lot for the proposed customers not being adequate for this business.

Pablo ORTIZ, Merced - asked if the revenue received could fix infrastructure and shared statistics on low crime rates around dispensaries.

Dwight LARKS, Merced - spoke on residential homes that grow cannabis with children around, the safety of the surrounding area of cannabis locations, and spoke in favor of the dispensary.

Devon JULIAN, Culture Cannabis Club, Applicant - spoke on the infrastructure issues surrounding the Motel areas, crime rates around dispensaries, security measures they are taking on the property, the zoning requirements being met, and the negative connotations of opening a bar in the place of the dispensary. He also spoke on the appellants arguments, the proposed measures to assist the appellant, the community's concerns, and urged Council to deny the appeal to move forward with the project.
