Tell us about yourself, and why you are applying for the City Council District 2 Seat:

I am 37 years old and have resided in Merced for the better part of 25 years. I currently work in I.T. for Merced County Office of Education. I have a 3 year old son which is my main motivation for wanting to join the City Council. My wife and I intend on raising him in Merced with all of our friends and their children so he will be attending Merced schools and joining Merced city sports teams etc. I want to do my best to make that experience for him and all Mercedians as positive as I can.

What would you bring in the way of perspective or experience to the City Council?

I consider myself highly analytical, detail-oriented, and goal-driven. I grew up in this city since moving here in the summer of 1999 and have witnessed its massive transformation firsthand. From the opening of the 'new' theatre downtown to the establishment of the UC campus, I have a deep appreciation for the great strides Merced has made in creating opportunity and promoting growth for its residents.

My professional background in Information Technology provides a unique and essential perspective for the City Council. In I.T., success relies on quickly diagnosing complex problems, understanding the interdependencies of various systems, and implementing efficient, scalable solutions.

I have also been a part of many of MCOEs new building purchases downtown so I am aware of the intricacies of large renovation projects including permitting, infrastructure, etc.

What is your understanding of the roles and responsibilities of a representative of Council District 2?

I see three main roles of any council member:

Advocating and being the voice of their constituents, whether by means of direct communication with them or through town hall/neighborhood meetings, and ensuring local infrastructure improvements, resolving zoning issues, and neighborhood safety and quality of life are prioritized in city planning.

Legislative work with other council members to introduce and vote on local laws and ordinances while simultaneously contributing to the long term vision of the city.

Budgetary work to make sure the city budget is passed and tax dollars are spent efficiently and responsibly.

What do you perceive to be the primary issues facing District 2 and issues for the whole city?

As a non-resident of district 2 I can not speak directly on the primary issues facing those residents currently, but i believe the primary issues will be reflective across all Merced residents.

Affordable housing is few and far between, many residents find that they can not afford to own a home and the cost of rent is astronomical. My priority would be to support city initiatives that streamline permitting for diverse housing types not just single-family homes.

Bringing in more jobs. While UC Merced is a driver of growth, the city needs to do more to attract employers that offer high-wage jobs to reduce the current high unemployment rate and the number of residents commuting out of the city for work. I would also like to see tech sector companies and jobs come to Merced.

Public safety and QoL improvements. I would like to focus on basic infrastructure like sidewalks, lighting, and street repairs. I would also like to ensure a fully staffed police and firefighter department to further improve the quality of life for our residents.

Any other comments you would like to add that may assist the City Council in their decision?

While I may not possess prior experience as an elected official, I view this as an opportunity to bring a fresh, solutions-oriented perspective to the Council. My candidacy is built on a deep commitment to Merced and a skill set optimized for modern governance.

If selected, I promise to be a fair, accessible, and dedicated advocate for the residents of District 2 and the entire city. I will diligently fulfill duties of this critical office, working collaboratively to translate the Council's vision into tangible, equitable improvements for all.

Tell us about yourself, and why you are applying for the City Council District 2 Seat:

My name is Ezekiel, but most people know me as Zeke. I have lived in District 2 since 2022, and my grandparents have been part of this community since 2018. I have seen firsthand the challenges we face — homelessness, limited business development, gang activity, and a lack of positive activities for our youth and families. As a young member of this community, I understand the importance of giving our youth opportunities and creating a safe, supportive environment where families can grow. District 2 is home to many hardworking, low-income, and migrant families who came here to build better lives. I want to be a voice for those families who often feel unheard. I believe in the potential of District 2. I want to change the narrative people use to describe our neighborhoods. We are not "dangerous," "ghetto," or "forgotten." We are a strong, resilient community — and with the right support, we can flouris

What would you bring in the way of perspective or experience to the City Council?

I bring the perspective of someone who has grown up and lives the everyday reality of District 2. I understand the challenges our families face because I see them directly — from housing struggles to safety concerns to the lack of activities and resources for young people. I have the perspective of someone who is not disconnected from the community, but truly part of it.

I also bring the experience of working with and listening to people in our neighborhood — students, parents, elders, and local workers. I know what it's like to navigate life in a low-income community where opportunities don't always come our way, and I'm committed to helping create those opportunities here.

While I may be younger than most candidates, I see that as a strength. I bring new energy, fresh ideas, and a long-term investment in the future of Merced. I'm not here to talk about what used to be — I'm here to focus on what can be. My goal is to make sure the voices of our youth, working families, and underrepresented communities are heard and included in the decisions that shape our district.

What is your understanding of the roles and responsibilities of a representative of Council District 2?

A representative of Council District 2 is responsible for being the voice of the community and making sure our needs are heard in City Hall. That means listening to residents, understanding their concerns, and bringing those concerns forward in city decision-making. A councilmember works on policies that affect everyday life — including public safety, housing, local business development, parks, road improvements, and community programs. It is also the responsibility of a councilmember to stay connected with the people they represent. That means attending community meetings, being accessible, answering questions, and being transparent about what decisions are being made. A representative should work with city departments, non-profits, and local organizations to bring resources into the district, not just talk abo

What do you perceive to be the primary issues facing District 2 and issues for the whole city?

For District 2, the primary issues I see are the lack of economic opportunities, limited youth programs, and concerns around safety. Our community needs more local businesses, activities and safe spaces for young people, and stronger support systems for families. We also face challenges with homelessness and the need for mental health and addiction services. These issues aren't just statistics to me — they're visible every day in our streets and neighborhoods.

For the city as a whole, some of the broader issues include affordable housing, citywide homelessness, public safety, and ensuring equal investment across all districts. Merced is growing, and we need to make sure that growth benefits everyone — not just certain neighborhoods. We need more job opportunities, more support for small businesses, and continued improvement in city infrastructure like roads, parks, and community centers.

Any other comments you would like to add that may assist the City Council in their decision?

Yes. I want to emphasize that I am deeply committed to District 2, not just for today, but for the long future ahead. I'm not running for personal recognition — I'm running because this is my home, and I truly care about the people who live here. I believe our district deserves representation that listens, understands, and takes action.

I know I am young, but that is my strength. I represent the voices of the youth and families who are often overlooked. I am a Baldrige Ambassador, Healthcare Management cum Physician Executive with over 25 years of cumulative Clinical Experience, and nearly 20 years of progressive American Healthcare Management and Physicians Practice Management experience. I am highly focused on Organizational Performance Excellence, Quality Patient Care, Prudent Fiscal Management and Resources Utilization, as well as Patients and Employees satisfaction. I have demonstrated skills and leadership in the areas of Physicians Practice Management; Population Health; Systems Redesign; Clinical Analytics; Performance Improvement and Quality Assurance; Risk Management and Mitigation; Access and Capacity Improvement; and Advocacy for Patients' and Staff Needs. I have been in the Executive Career Field as far back as 2009 at the Federal and County levels and provided Consultant services to the State of California over the years. I previously served as an Appointed Member to the City of San Jose' Senior Citizens Commission (2019-2022) and have served on multiple National and Regional Boards focused on Organizational and Governmental Performance.

What would you bring in the way of perspective or experience to the City Council?

Continuing from the last question above, I am applying for the District Council District 2 Seat to be able to use my wealth of experience to facilitate rapid development of District 2 and, indeed, the City of Merced, and address the needs of the residents of the district. My main work office and location are situated in the District 2, and I am conversant with the needs and struggles of the residents of the various communities within the district.

As far as the perspectives and experience I would bring to the City Council are concerned, there a good number of them that readily come to mind that the allotted space here may not allow me to dwell in, but I would highlight some of them briefly.

As a Physician and Healthcare Executive involved in the running of large healthcare systems at the County and Federal level, and as Medical Schools Faculty, my experience will provide the City internal subject matter expertise that could help reposition the healthcare services to the City of Merced Residents in ways that better meet their needs at more reasonable cost. Additionally, as a County of Santa Clara Executive for 8 years, and a Federal Executive for another 8 years running large interacting with vendors, labor unions and other external and internal stakeholders, I've got a great deal of perspective and experience that can strengthen and support all the other members of the City Council to meet the needs of their district residents and the City. More importantly, my network within the Country can be tapped into to alleviate the current difficult professionals and workforce recruitment challenges in the City.

What is your understanding of the roles and responsibilities of a representative of Council District 2?

My understanding of the Roles and Responsibilities of the Representative of Council District 2, or any District Representative for that matter, goes beyond being just the face of the District in the City Council Chamber. Other responsibilities include being the voice and ears of the District 2 Residents in the Council; making oneself available to the Residents on periodic, and on as needed, basis to hear their concerns, address their needs and keep them abreast of the activities and the goals and works of the City council.

The District 2 Representative is also expected to work alongside other City Council members to facilitate developments to the District and elsewhere in the City of Merced. My name is Katherine Escobar. I am 24 years old and I hold a bachelor of arts degree in psychology. I am applying for the District 2 City Council seat because I care deeply about the future of our community and I am ready to step into a leadership role. Even though I am young, I see that as a strength. I bring a fresh perspective, strong energy, and a real understanding of the challenges that people face today.

I am Puerto Rican and Hispanic and I was born and raised in New York City before moving to California. Growing up in a diverse and very fast paced environment shaped how I communicate, how I solve problems, and how I support others. My background in psychology also taught me how to understand people, listen fully, and work with empathy, which I believe are important qualities for a public leader. I learned early in life how important representation is, especially for communities that do not always feel seen or heard. That is one of the biggest reasons I am running. I want people in this district to feel that their voices matter and to see themselves reflected in their leadership.

Tell us about yourself, and why you are applying for the City Council District 2 Seat:

I am a lecturer at the University of California at Merced and have made this city my home since 2018. I strongly believe that wherever I live, I must be responsible to my immediate community, hence my choice to serve as a Culture and Arts Commissioner even though I may not have Merced roots. Although I do not live in District 2, I am very well acquainted with the socioeconomic data of this area and its present challenges. The cultural richness of this area is also remarkable in spite of its many issues and relative underdevelopment. I know that this area has some of the city's highest poverty rates and lacks substantial access to grocery stores and commercial services while it bears the brunt of industrial development. While the rest of Merced has been experiencing a building boom and drastic changes that improve overall quality of life, it seems that District 2 is as yet left out and continues to be wrongfully ignored.

What would you bring in the way of perspective or experience to the City Council?

I will be upfront that I am a bit of an outsider, even though I have lived here since 2018. I understand that Merced's distinctive local culture and sense of self-identity tends to emphasize local roots, but perhaps I can offer a fresh perspective to the city. Furthermore, as I do not have as much stake in the various competing interests in the city, perhaps I might be able to speak on behalf of a district that has long been marginalized. Furthermore, I have some ability in Geographic Information Systems analysis so I may be able to leverage actual data for decision making and policy discussions.

What is your understanding of the roles and responsibilities of a representative of Council District 2?

I understand that I must be both a listener and a voice and that I must weigh often-contradictory needs and desires in order to make the best possible decision for the residents that a councilor represents. Given District 2's socioeconomic character, this would be an extraordinarily complicated responsibility.

What do you perceive to be the primary issues facing District 2 and issues for the whole city?

District 2 continues to lag behind the city in terms of development, investment, and quality of life. As Merced diversifies economic functions, it seems that District 2 bears the brunt of industrial development's consequences. While more jobs are absolutely necessary for this city, I think we need an honest discussion about how to make these decisions fairer for District 2 residents.

Any other comments you would like to add that may assist the City Council in their decision?

I intend to serve to the best of my ability as an interim councilor even though I may not be specifically a resident of District 2. I understand that tensions can get a bit high as council meetings can bring out passions. My long experience as an educator (especially prior elementary and middle school teaching experience!) has enabled me to hone my patience.

Interests & Experiences

1. Tell us about yourself, and why you are applying for the City Council District 2 Seat:

I was born in Laos and came to the United States in 1991 when I was seven years old. My family made Merced our home, and I have lived in District 2 for nearly my entire life. I attended Merced schools and later earned a Bachelor of Science in Community Health from Fresno State. After college, I returned home because this community raised me, and I wanted to build my life here.

Over the past twenty years, I have worked in public service, nonprofit leadership, and financial services. During the H1N1 emergency response, I educated residents, health educators, and nurses on prevention and vaccination practices, and helped prepare emergency evacuation and mass-care sites. Later, in the Small Claims Court system, I guided residents through filing requirements, evidence preparation, and court procedures.

I have also managed nonprofit programs that support families and youth through budgeting, cultural preservation, mentorship, and community outreach. In the financial sector, I train and mentor agents and help families strengthen their financial stability.

For the past two years, I have served on the Merced Planning Commission, reviewing zoning amendments, subdivisions, conditional use permits, and development proposals. This experience strengthened my ability to evaluate staff reports, consider neighborhood impacts, and make decisions aligned with city policy and long-term planning goals.

I am applying for the District 2 seat because this district shaped who I am. Many of the oldest neighborhoods—particularly those south of Childs Avenue and west of MLK—are long overdue for reinvestment in lighting, sidewalks, alleys, and drainage. I want to help modernize how repairs are prioritized so areas with aging infrastructure and high foot traffic are addressed more efficiently. District 2 deserves a dependable voice that understands its history and its needs.

My role, if appointed, is to serve District 2 while also supporting policies that move the entire City of Merced forward. Strong districts create a strong city, and both responsibilities go hand in hand.

2. What would you bring in the way of perspective or experience to the City Council?

I bring the perspective of someone who grew up in District 2 and understands the daily challenges facing families in the historic core of the district, especially in the neighborhoods near Childs Avenue, V Street, and MLK. These areas reflect both the struggles and the potential of our community.

My career has been rooted in service. During the H1N1 response, I worked in public health supporting emergency preparedness and community education. In Small Claims Court, I helped residents navigate complex legal procedures. These roles strengthened my communication skills and my ability to guide people through government systems.

As a nonprofit program manager, I oversaw budgets, coordinated volunteers, prepared grant reports, and supported youth and family programs. In the financial sector, I train and support agents, lead workshops, and help families plan long-term financial strategies.

My Planning Commission experience is one of my biggest strengths. I have reviewed residential and commercial proposals and balanced resident concerns with staff recommendations. This experience has prepared me to evaluate development, infrastructure impacts, and zoning decisions with fairness and practicality.

I also support balanced and responsible housing growth. My vision includes more affordable and mixed-density housing options that fit the character of the neighborhoods along Childs, Canal Street, and MLK, while ensuring infrastructure improvements keep pace with development.

Together, my public service background, community involvement, and Planning Commission experience give me a grounded, thoughtful perspective I will bring to the City Council.

3. What is your understanding of the roles and responsibilities of a representative of Council District 2?

A council representative must balance district needs with citywide responsibilities, ensuring that policies support both the residents they represent and the long-term health of the entire City of Merced. A representative must listen to residents, respond to concerns, and ensure community voices guide city decisions.

The role requires reviewing budgets, development proposals, capital improvement plans, and policy updates with a focus on safety, infrastructure, fiscal responsibility, and long-term impacts. A councilmember must communicate clearly, work collaboratively with staff and fellow councilmembers, and ask informed questions. They should evaluate each issue on its merits, using facts, staff analysis, and community input.

My Planning Commission service has prepared me to read and interpret staff reports, zoning proposals, and infrastructure impacts. I understand how land-use decisions affect neighborhoods along Childs, Canal, MLK, and V Street, where many of the district's infrastructure and safety concerns require close attention.

If appointed, my first 90 days would focus on walking the neighborhoods in the central part of the district, meeting with residents and city staff, reviewing ongoing infrastructure projects, and identifying urgent priorities.

4. What do you perceive to be the primary issues facing District 2 and issues for the whole city?

Much of the aging infrastructure and reinvestment needs in District 2 are concentrated in the central neighborhoods south of Childs Avenue and west of MLK. These areas face several longstanding challenges:

• Public safety issues — including speeding, insufficient lighting, and inconsistent visibility at key intersections

- Illegal dumping and blight especially in older alleyways near Canal Street, T Street, and the MLK corridor
- Aging infrastructure drainage problems, sidewalk gaps, poor pavement, and alleys that have not been modernized in decades
- · Limited youth programs and safe community spaces
- Underinvestment in parks and small strip parks, including areas surrounding McNamara Park and the Childs corridor

Another priority for me is the condition of our neighborhood parks. In these older neighborhoods, families rely on several small strip parks for daily play and outdoor activity. I would like to work with the City to establish a scheduled maintenance cycle to ensure these parks remain clean, safe, and welcoming. Regular upkeep strengthens community pride, supports youth, and improves quality of life.

I also want to work with City staff and engineering to help create safe cycling corridors that connect the neighborhood streets of District 2 to the larger bicycle and pedestrian network in Central and North Merced. Families should have safe, reliable routes for recreation, school commuting, and accessing community amenities. Better cycling connections will strengthen safety, mobility, and neighborhood connectivity.

Citywide, Merced faces broader issues that directly affect District 2:

- · Access to affordable housing and responsible growth
- · Supporting local businesses and job creation
- · Long-term planning for traffic, streets, and infrastructure
- · Maintaining strong levels of public safety staffing
- · Building trust and communication between residents and the City

My approach to the budget is to prioritize essential services first—public safety, clean neighborhoods, and infrastructure maintenance. I also believe in transparency and support providing residents with simple and accessible information about how city funds are allocated.

District 2 must be included in Merced's long-term planning, and the city must reinvest in its oldest neighborhoods to ensure equitable growth.

5. Any other comments you would like to add that may assist the City Council in their decision?

My connection to District 2 is lifelong. I grew up in the neighborhoods south of Childs Avenue and west of MLK, and these communities shaped who I am. I understand the challenges and strengths of this area because I lived them firsthand.

I bring experience in public service, nonprofit management, financial literacy, and land-use decision-making. I will approach the budget responsibly, support essential services, and advocate for reinvestment in the district's aging neighborhoods. I also believe strongly in transparency—residents should easily understand how their tax dollars are used.

If appointed, I will work collaboratively with residents, city staff, and the council. I am ready to serve with integrity, respect, and a commitment to improving the quality of life for every resident of District 2 and strengthening the city as a whole.

I am prepared to begin this work on day one.
