THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING is made and entered into this ____ day of _____, 2025, by and between the City of Merced, a California Charter Municipal Corporation (hereinafter referred to as the “City”), the County of Merced, a Political Subdivision of the State of California, (hereinafter referred to as the “County”), the Merced Union High School District (hereinafter referred to as the “MUHSD”), the Merced County Office of Education (hereinafter referred to as the “MCOE”), referred to collectively herein as the “Parties” and each “Party”.

WHEREAS, the Parties entered into a Memorandum of Understanding dated October 17, 2023 (“MOU”); and,

WHEREAS, the Parties desire to amend the MOU to extend the term.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 3, “TERM OF THE AGREEMENT,” of the MOU is hereby amended to read as follows:

“The term of this Agreement shall commence from the date it is fully executed by the Parties and continue until June 30, 2026, unless sooner terminated as provided herein. This agreement may be executed through execution of an amendment by the Parties.”

2. Except as herein amended, the MOU dated October 17, 2023, shall remain in full force and effect.
