

RESOLUTION NO. 2023-_____**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
RESCINDING RESOLUTION NO. 2010-95 AND
ESTABLISHING PARKING PENALTIES AND
CHARGES AND AUTHORIZING THE CITY
MANAGER TO IMPLEMENT ADMINISTRATIVE
POLICIES AND PROCEDURES FOR
PROCESSING PARKING CITATIONS**

WHEREAS, California law provides in Vehicle Code Section 40203.5 that cities establish the amount of parking fines; and,

WHEREAS, California law authorizes the governing body of the jurisdiction where the notice of violation is issued to recover administrative fees, processing service fees, fees and collection costs related to civil debt collection, late payment penalties and other related charges; and,

WHEREAS, AB 1617, which modified state law effective December 7, 2010, increased the state surcharge on parking penalties and charges imposed by cities; and,

WHEREAS, California law authorizes the governing body of the jurisdiction where the notice of violation is issued, establishment of the policies and procedures to collect the fines and other penalties and establish a review process relating to such parking violations.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MERCED DOES HEREBY RESOLVE, DETERMINE, FIND, AND ORDER AS FOLLOWS:

SECTION 1. Resolution No. 2010-95 is hereby repealed.

SECTION 2. The parking penalties for parking violations, late payment penalties, administrative fees and other charges set forth in Exhibit "A," which is attached hereto and incorporated herein by this reference, are hereby established.

SECTION 3. The City Manager is hereby authorized to implement and modify administrative policy and procedure regarding parking citations and their administrative adjudication.
