Acting City Attorney Travis LINDSEY gave a slideshow presentation on the potential Urgency Ordinance related to the displacement of residents from rental housing due to storms and flooding.

Council, Mr. LINDSEY, and City Manager Stephanie DIETZ discussed the percentage of residents affected by floods without Flood Insurance, cost of repair for rental units, permit process for owners, amount of residents affected by the floods, and details of the potential Urgency Ordinance.

Concerned Citizen, Merced - spoke on history and statistics of rent control.

Concerned Citizen, Merced - spoke on rent control decreasing rental housing.

Concerned Citizen, Merced - spoke against placing a rent control policy due to the economical impact.

Concerned Citizen, Merced - spoke on studies on rent control.

Concerned Citizen, Merced - spoke against rent control due to the economical housing impact and suggest more housing, retails industries, and rental market.

Erin HAMM, Merced - shared information on how Rental Zebra is assisting their tenants affected by the floods and spoke on the negative impact rent control can have on the community.

Jamie TERRIBAL, Merced - encouraged Council to continue discussing the rent control policy while working with rental management companies for a positive impact on the community.

Alicia HANSEL, Merced - asked Council to have conversations with property owners and rental management companies.

Roshni GARCIA, Merced - spoke against rent control due to the negative impact it has on business and the community.

Clerk's Note: The following speakers appeared in person.

Gloria SANDOVAL, Merced - spoke on the residents affected by the floods, asked Council to support the Urgency Ordinance due to the local emergency.

Pangcha VANG, Merced - asked Council to support the rent control ordinance, pause on rental increase, and spoke on the robotic calls received.

Blanca OJEDA, Merced - spoke on the groups of residents that were evicted, eviction protection for tenants, rents stabilization, and Right to Counsel.

Josue HERRERA, Merced - spoke on the Urgency Ordinance partnering with tenants affected by evictions and suggested to take additional measure rather than just rent control.

Greg TERRAKIS, Merced - spoke in opposition of the discussion of the ordinance and shared the actions that Buckingham Property Management took during the floods.

Elyse REDDEN, Merced - suggested a Right to Counsel, the habitability issues, and the idea of disaster preparedness.

Rick WENDLING, Merced - asked Council to fix the permitting process, spoke on rent control, and the Federal Emergency Management Agency (FEMA).

Salvador SANDOVAL, Merced - spoke on the recent flood events, the importance of the Urgency Ordinance, and the health and safety concerns due to lack of housing.

Madeline HARRIS, Leadership Counsel for Justice and Accountability, Merced - explained details of the Urgency Ordinance, details of the staff report, shared Cities that have passed Urgency Ordinance, and urged Council to approve an eviction moratorium and a temporary pause of rental increases due to floods.

Robert DYLINA, Merced - stated that property owners and tenants are both victims of the floods and lack of housing.

Council Member SMITH, Mrs. DIETZ, Development Services Director Scott MCBRIDE, and Mr. LINDSEY discussed previous rental properties issues, communication with the Woodbridge Apartments, the amount of units or tenants that need assistance, details of the ordinance, details of requirements for potential policies, the impact of property damages from floods, time frame of adopting the ordinance, and sunset dates.

Council agreed to include six months of no rent increase (rent pause) moratorium, six months of Just Cause Eviction, six months of Right of First Refusal in the Urgency Ordinance for property owners and tenants impacted by the floods and within the perimeters of the State of Emergency, and bring an urgency and regular Ordinance back to Council.
