CE #007 - 20in Influent Pipe Replacement

The existing 20" pump discharge lines that are called out to be blasted and recoated have significantly deteriorated due to the H2S environment in the wet well. The client is requesting a proposal to replace the four pump discharge lines with SST 316 sch 40 piping. The existing pump base 90s will be removed to sandblast and recoat the interior and exterior. All six existing wall spools will be removed and new SST 316 wall spools will be cast back in place. The new concrete at the wall spools will be sandblasted and coated with Perma Shield Epoxy. Installation of new spools would be in two phases: one wet well at a time. Fabrication lead time is 9 to 10 weeks after approved submittals. A contract time extension will have to be granted to allow for the fabrication and installation of the spools.
