# FIRST AMENDMENT TO SERVICES AGREEMENT LANDSCAPE MAINTENANCE

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this day of, 2025, by and between the City of Merced, a California Charter Municipal Corporation ("City"), and Central Valley Lawnscapes, a California Corporation, ("Contractor").
WHEREAS, City desires to engage Contractor to render landscape maintenance services; and,
WHEREAS, City and Contractor have previously entered into a Services Agreement Landscape Maintenance ("Agreement") dated October 3, 2023; and,
WHEREAS, City and Contractor desire to amend said Agreement to change service frequency within specified districts.
NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:
1. All references to Exhibit B shall be changed to the updated Exhibit B attached hereto.
2. Section 23, "ADDITIONAL COMPENSATION," is hereby added to the Agreement to read as follows:
City shall pay Contractor the not to exceed additional sum of total of Nine Thousand Five Hundred Eighty-Eight Dollars (\$9,588) annually in accordance with the service rates set forth in Exhibit B, for a total contract not to exceed amount of Three Hundred Seventy-One Thousand One Hundred Forty-Eight Dollars (\$371,148) annually.
3. Except as herein amended, the Agreement dated October 3, 2023, shall remain in full force and effect.

### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
