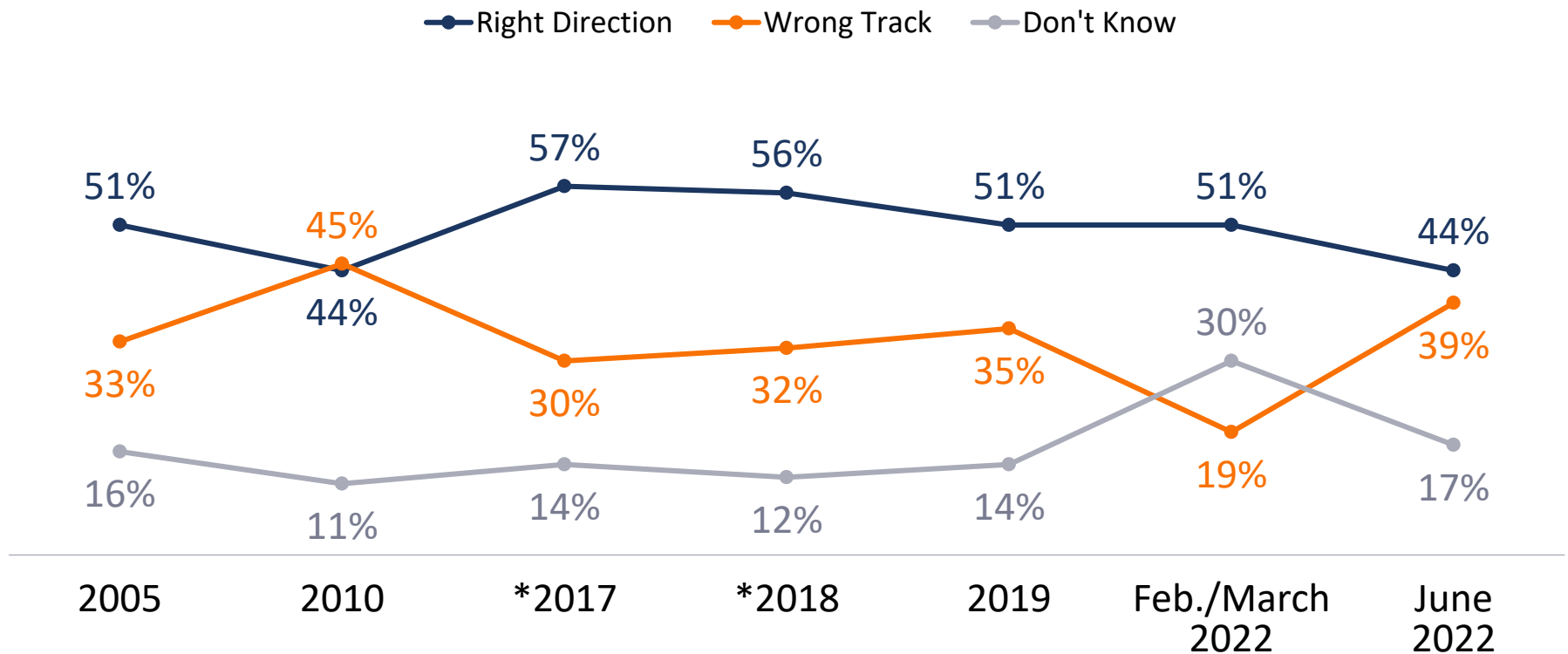

Views of Life in Merced

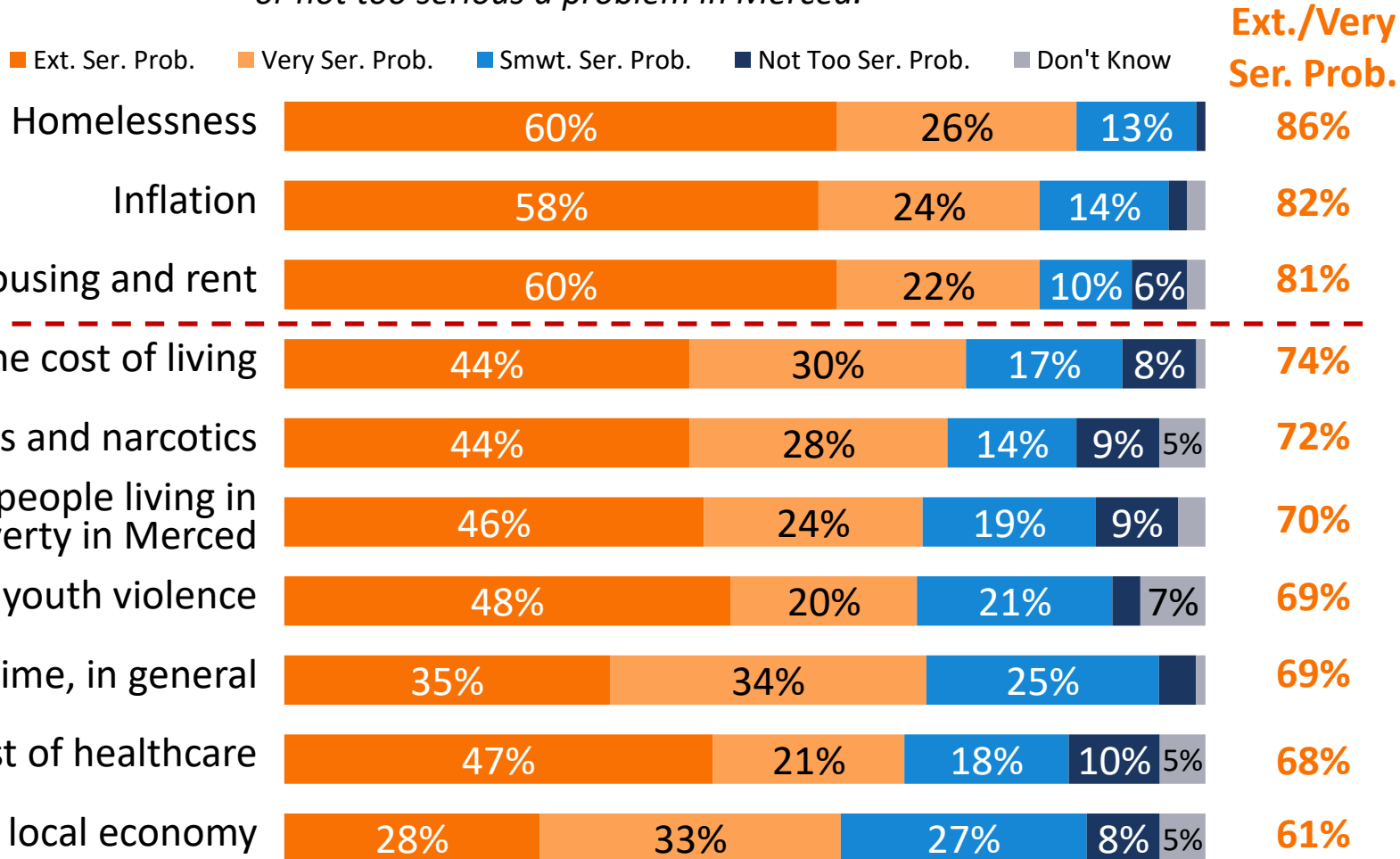
Respondents appear concerned about the direction of Merced.

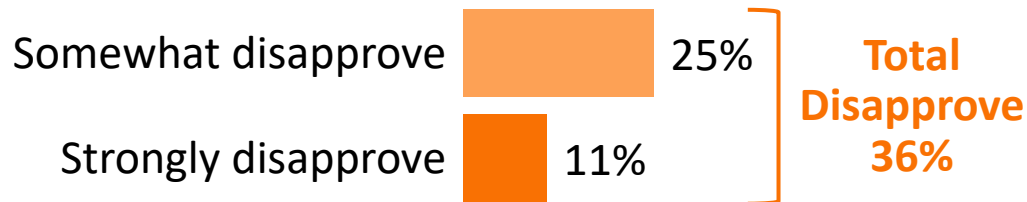

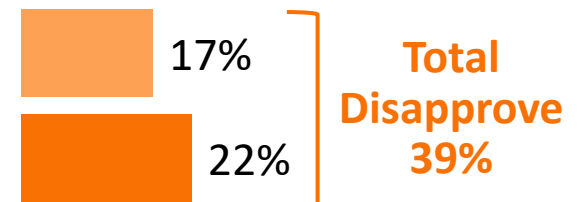
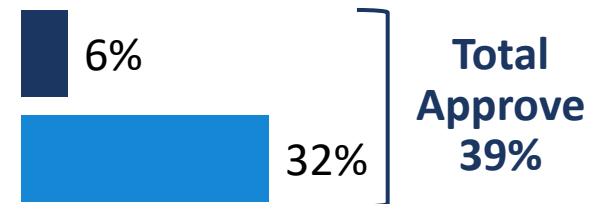
Do you generally approve or disapprove of the City of Merced's financial management?

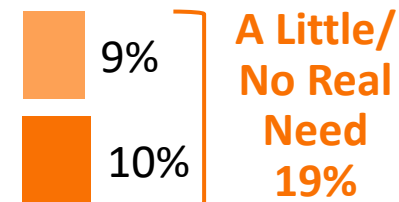

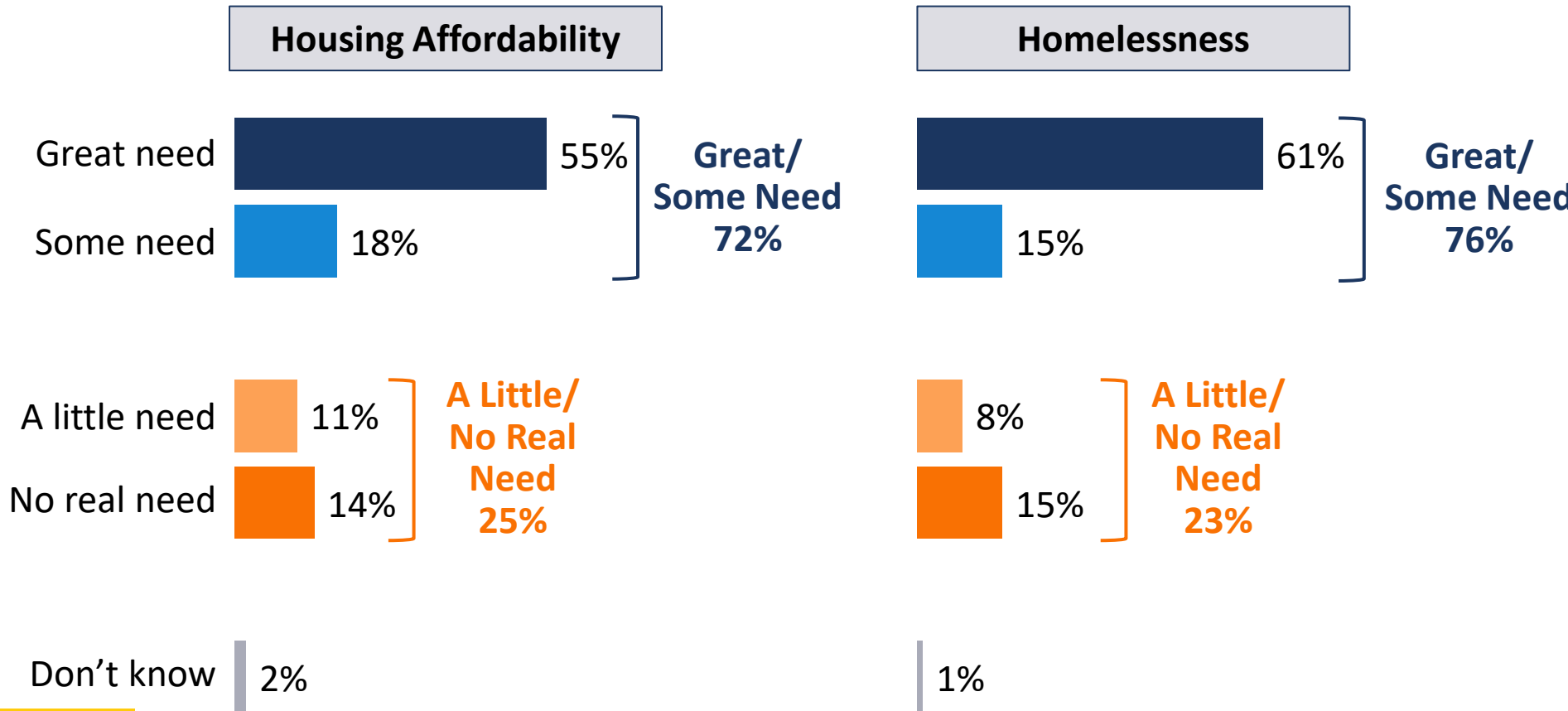

Comprehensive Renewal Measure Including Housing

Question reviewed by City Attorney: Half Sample; 50% Threshold

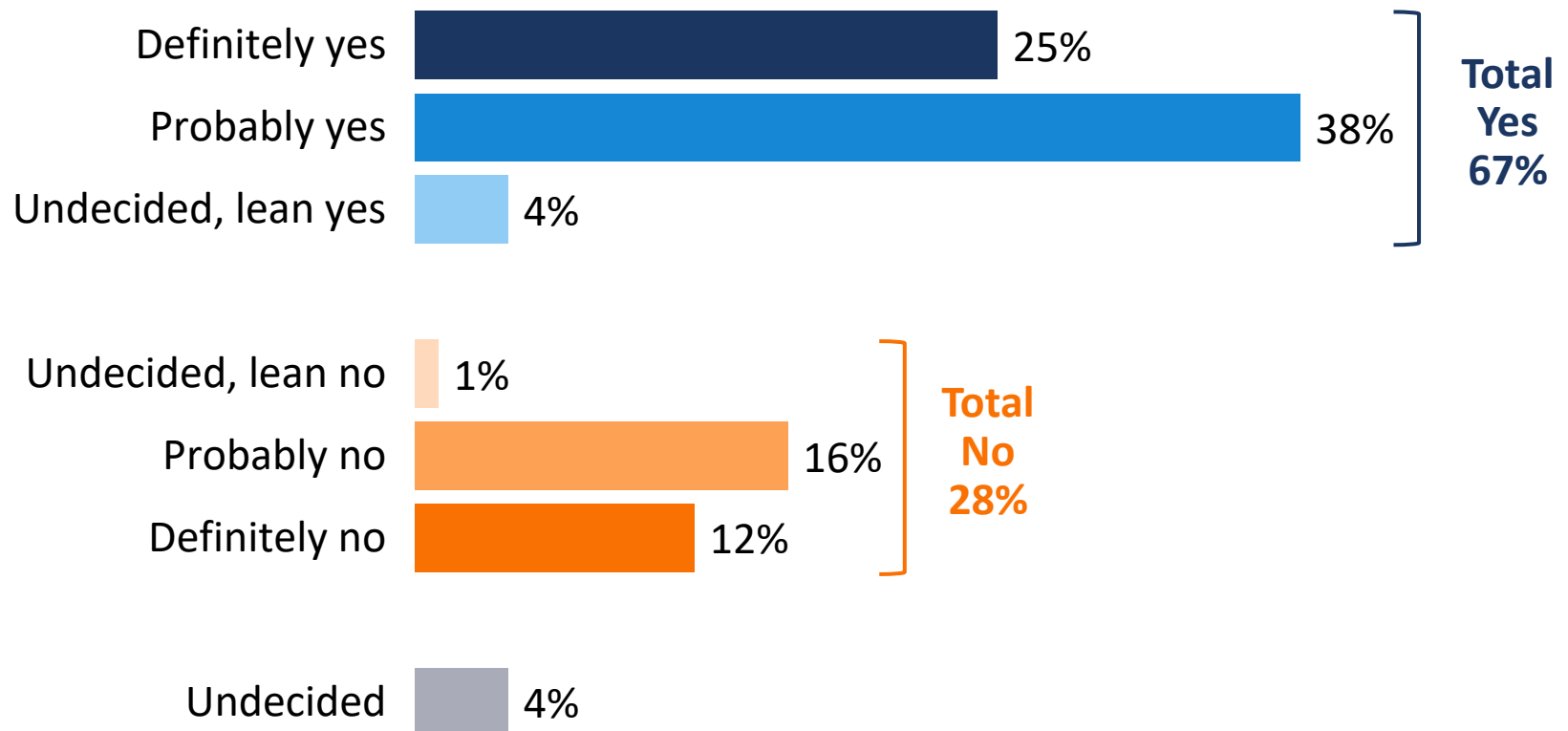
City of Merced Vital Services Renewal/Housing Measure.

Shall a measure to maintain local services, such as 911 fire/police/medical/natural disaster response; community policing/gang prevention programs; youth services/job training; pothole repair; other general city services, and provide funding for affordable housing/addressing homelessness by renewing an existing voter-approved sales tax at the 1¢ rate, until ended by voters, providing approximately \$13,000,000 annually, with citizen oversight, financial audits, all funds local, be adopted?

Two-thirds were supportive of a Measure C renewal that included funding for housing.

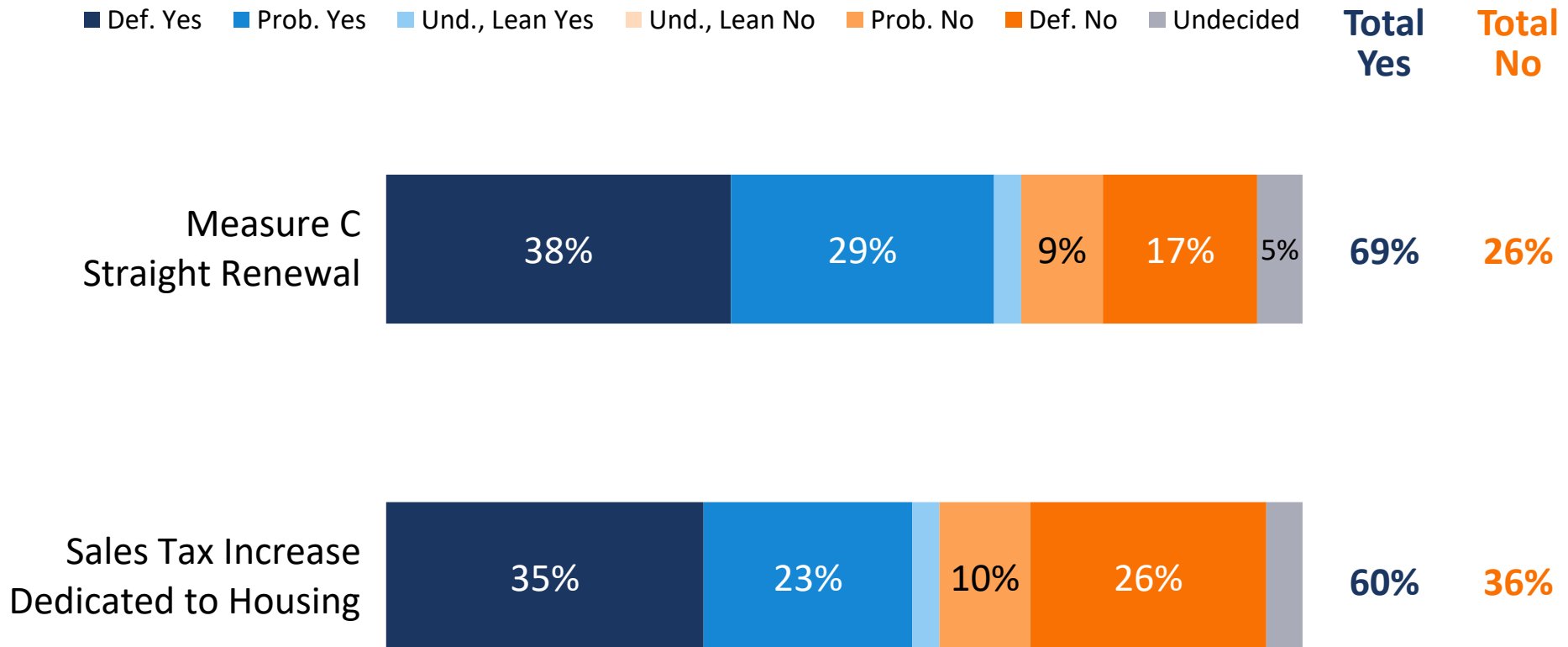
50% Threshold

City of Merced Vital Services Renewal Measure. Shall a measure to maintain local services—without raising current tax rates—such as 911 fire/police/medical/natural disaster response; community policing/gang prevention programs; youth services/job training; pothole repair; housing/homeless services; and other general city services, by renewing an existing voter-approved ½¢ sales tax, until ended by voters, providing approximately \$6,500,000 annually, with transparency, independent audits, all funds local, be adopted?

67% Threshold

City of Merced Housing Affordability Fund Measure. Shall a measure to provide city funding for affordable housing options for city residents/working families; such as creating affordable housing with State matching funds; providing rental and first-time homebuyer assistance; addressing homeless encampments; and providing services to get residents off local streets, by enacting a voter-approved ½¢ sales tax, until ended by voters, providing approximately \$6,500,000 annually, with citizen oversight, independent audits, all funds local, be adopted?

When split into two half-cent measures, support for the renewal was consistent, but the dedicated housing measure did not reach two-thirds.

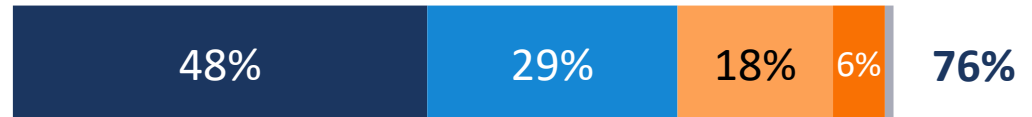

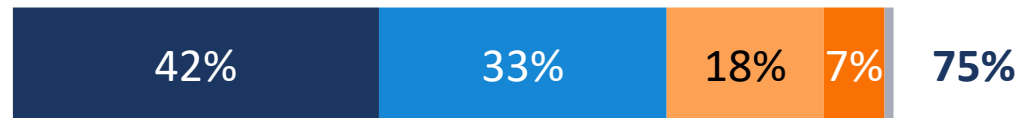

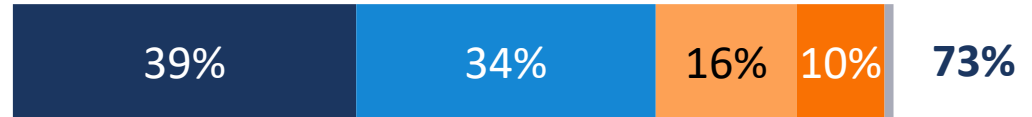

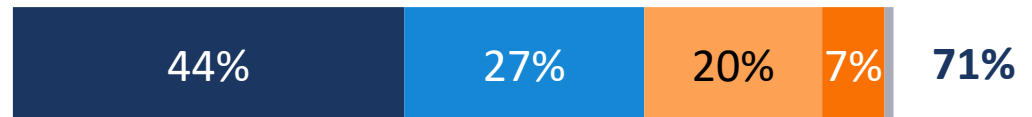

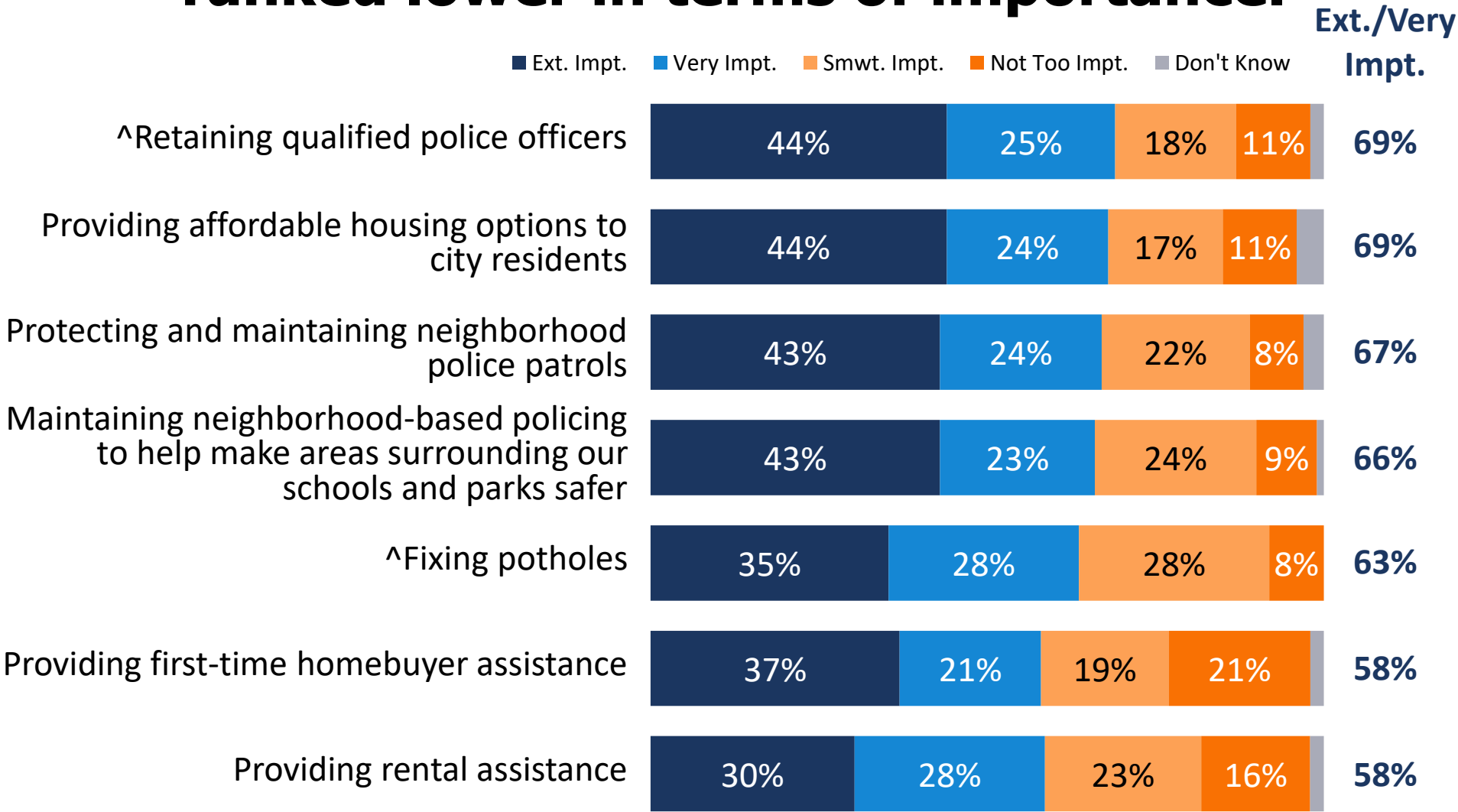

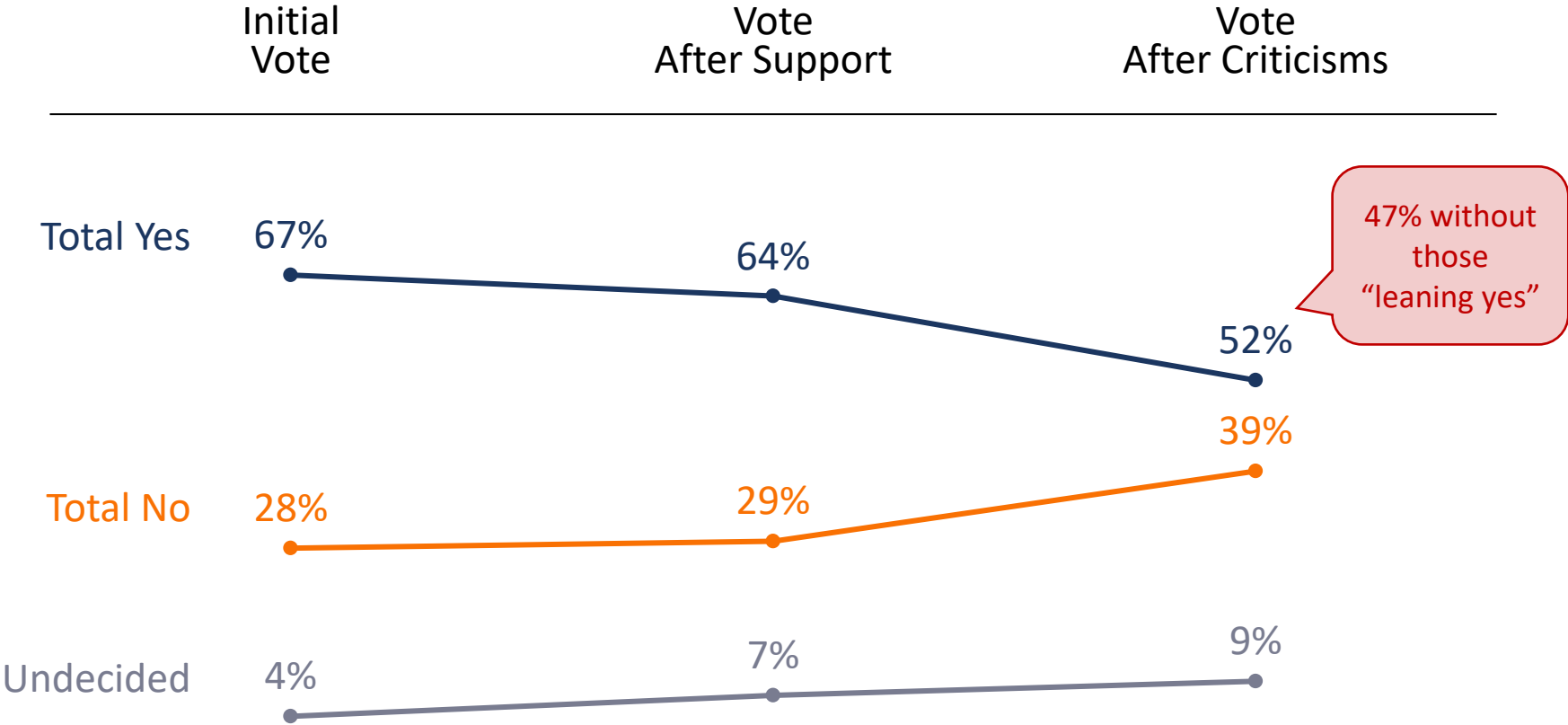
The Impact of Information

Supportive and Critical Statements

- Statements supportive of the measures included that the funds generated would fund crime and gang prevention, emergency response; street repair and maintenance, homeless services, making housing more affordable, and maintaining the local quality of life; that the funds would be under local control, subject to oversight, and allow access to matching funds; and that the tax would not apply to necessities. For the straight Measure C renewal, there was also a statement clarifying that it would not increase tax rates.
- Statements critical of the measures highlighted the regressive nature of sales taxes; argued that existing taxes are already too high and that the cost of living keeps increasing; asserted that funds would be wasted on high salaries and pensions and the City already has enough money; noted that the taxes would last forever; and argued that the funds should go to services that benefit all residents and not handouts to homeless people. For the Measure C renewal with expansion, there was also a statement arguing that it was deceptively framed as a renewal when it is actually a sales tax increase.

Support for the expanded Measure C renewal with housing remained above the 50% threshold throughout the survey with leans, although after critical statements support dropped within the margin of error and below 50% when “leans” are eliminated.

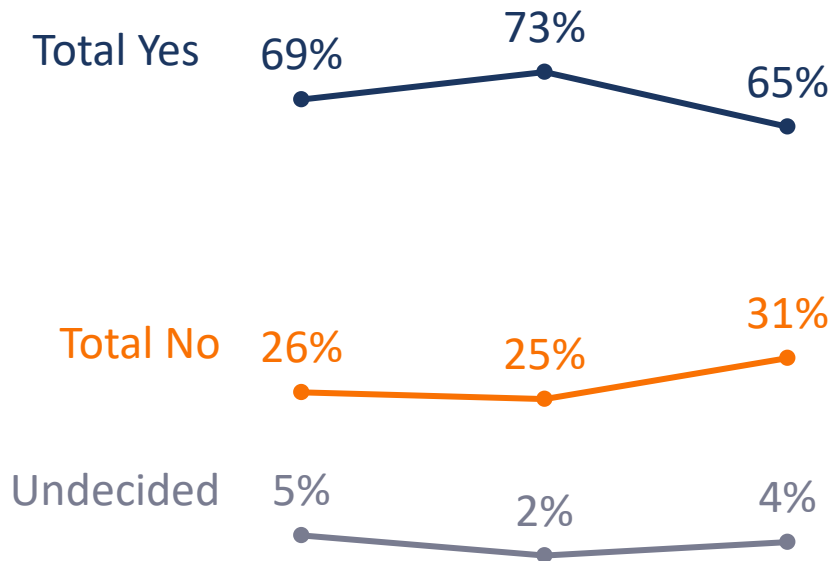
Half Sample: Measure C Renewal With Housing



Support for a Measure C renewal without housing appeared consistently viable, while a dedicated sales tax fell below two-thirds after criticisms.

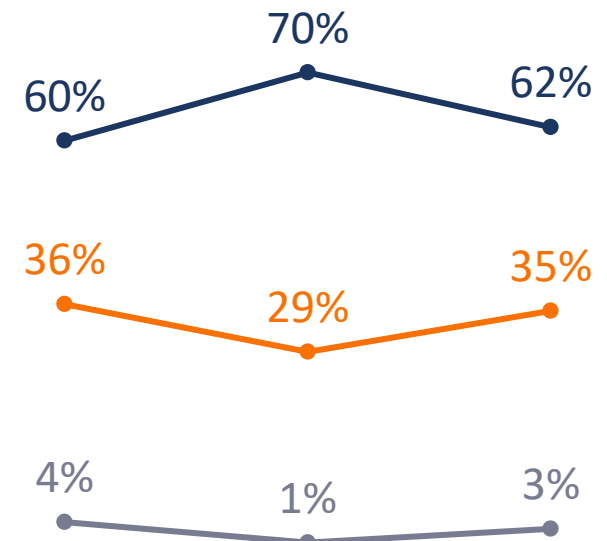
Measure C Straight Renewal

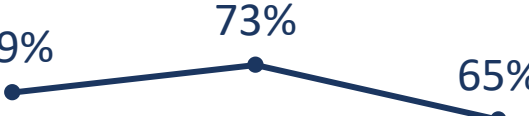


Support for a straight Measure C renewal until ended by voters was at similar levels earlier in 2022.
