McKee Fire Station Closure



 Merced County closure of Station 85 to consolidate staffing and meet the states mandated requirement of 2 personnel per apparatus. (Effective Jan. 1, 2025)

 Merced County staff request our assistance in providing fire coverage to County jurisdiction generally located North of Hwy 140, West of Kibby Road, West of N. Lake Road, and East of G Street via automatic aid agreement


What are the types of aid Fire Departments use?




- Mutual Aid
 - Assistance agreement between jurisdictions to provide services upon request on a case-by-case basis.
- Auto Aid
 - Assistance automatically by contractual agreement between two communities to emergency incident.
- Service Contracts
 - One jurisdiction assumes all service needs for a defined area.

MERCED FIRE RESCUE

- Reciprocal Automatic Aid Agreement
 - Prior council considerations 5/6/2024 Not Supported



- Prior council considerations
 - Service Agreement Council direction was to explore service agreement options. (5/6/24 Council meeting)
 - City of Merced provides service to the unincorporated area of North and Northeast of the City of Merced for a fee to recover cost of service.






Fire and EMS Aid Agreement – Options Considered


MERCED FIRE RESCUE

- Fee for service per incident
- Hourly based fee for service
- Partnership approach for staffing of Squad 53

Current Distribution based on 2023 Data using a 4-minute travel time

- Partnership approach for staffing of Squad 53 provides benefit for the City adding capacity for response in North Merced.
- Squad 53 will also support additional calls for service generated by the recent annexation of UC Merced.

Merced City Limits


CO 85 Calls 2023

 2023 Data Indicates 417 calls for service in this area.




FIRE RESCUE

Fire and EMS Aid Agreement – Responsibility

- EMS response
- Initial response
- Incident stabilization
- Merced County would assume incident command responsibly upon their arrival for fire incidents
- Merced County Fire would retain prevention and investigation responsibility
- Collaborative approach City does not have the equipment to assume full responsibility of this area



- Automatic Aid Map
- 1/3 of personnel staffing cost for Squad 53
- Term Expire 12/2026 to align with SAFER staffing expiration



FIRE RESCUE

Staff Recommendation

 Staff will continue conversations with Merced County and bring back a fair and equitable aid agreement that will enhance partnerships with Merced County and ensure a high level of fire protection and EMS service is maintained.
