California's Opioid Bankruptcies Expenditure Reporting Form

Local Governments receiving funds from opioid bankruptcies are required to complete annual reporting on the use of these funds. Currently, California has reached a final <u>Statewide Allocation Agreement</u> with Mallinckrodt Pharmaceuticals. Funds from the Mallinckrodt Bankruptcy are distributed directly to Local Governments from the National Opioid Abatement Trust II Fund (NOAT II).

This form is intended to collect expenditure information from Local Governments receiving payments from NOAT II. A list of Local Governments can be found within California's Mallinckrodt Statewide Allocation

Agreement. If you have questions about your Local Government's status, please reference this agreement, or contact your city, county, or outside counsel handling opioid related matters.

This reporting form covers the period of July 1, 2022 – June 30, 2023. Please ensure all responses reflect the 2022 – 2023 State Fiscal Year (SFY).

The reporting period will run through **November 30, 2023.** For the SFY 2022-2023 reporting period, DHCS will allow a one-time grace period for expenditure form submissions and will accept submissions until **December 31, 2023.**

Submission Requirements

Local Governments shall only submit one (1) expenditure report annually for bankruptcy funds received from NOAT II.

Do not send this expenditure reporting form to contractors or subgrantees to whom you may have awarded your bankruptcy funds. Local Governments are responsible for the oversight and disbursement of funds for opioid abatement. It is the Local Government's responsibility to collect all required information regarding the funds they have received and expended and to compile it into a singular report. The preparer of the Mallinckrodt Bankruptcy Expenditure Report should be the only person to submit one (1) expenditure report for your Local Government.
