Principal Planner Jonnie LAN and Management Analyst Leah BROWN gave a slideshow presentation on the proposed rezoning for the Housing Element and details of the General Plan Amendment.

City Attorney Craig CORNWELL briefly explained that Council Member HARRIS and Council Member DEANDA will need to recuse themselves from specific sites due to the proximity of their address.

Council, Mrs. LAN, and Mrs. BROWN discussed the difference of the presentation given at the workshop, details of the attachments, the range for rezoning, details of a site on Gerard Avenue, details of the proposed properties, and affordable housing.

Mayor SERRATTO opened the Public Hearing at 7:49 PM.

Jean OKUYE, Merced - urged Council to vote no and spoke on aligning the General Plan Amendment to fill the needs of the community.

Hugo CASTRO, Merced - asked Council to reject the rezoning proposal, spoke on future growth of the City of Merced, and details of developing affordable and low-income housing.

Ana QUINTANA-CEJA, Merced - shared details on where to place affordable housing sites in South Merced and improving current properties.

Olajide OQUNMAKUY, Merced - spoke on the importance of developing bicycle and pedestrian lanes and the lack of walkable areas.

Gloria SANDOVAL, Merced - spoke on details of the Housing Element, details of the proposed rezones, and the affordability of homes in the city.

LaTanya RICHARD, Merced - shared details of health concerns from unsafe housing, spoke on a rental registry, and requested an audit of the City's budget.

Ashley SUAREZ, Merced - spoke on fair housing, creating safe housing for all income levels, details of the proposed properties being rezoned, and details of the placement of affordable housing.

Mayor SERRATTO closed the Public Hearing at 8:11 PM.
