Samuel Stodolski issues this notice in his official capacity as the Deputy Chief of the Bureau of Security and Investigative Services, hereinafter referred to as the "Bureau".

Licensing History

The records of the Bureau show that a private patrol operator license was issued to Hastings Patrol Services, as a sole proprietor, on May 10, 2016 and expires on May 31, 2024, unless renewed. The records of the Bureau further show that a private patrol operator qualified manager certification was issued to Joe A. Onate on November 30, 2015, does not expire and was associated to Hastings Patrol Services on May 10, 2015.

Citation

A citation is hereby issued to Hastings Patrol Services and Joe A. Onate in accordance with Business and Professions Code (BPC) Section 125.9 and 7587.8(a) for violation of the following:

1. BPC Section 7583.2(c) – Failing to properly maintain an accurate and current record of proof of completion by each employee of the licensee of the trainings and for the retention.

Cause for Citation

As a result of a Bureau investigation, it was discovered that Hastings Patrol Services and Joe A. Onate committed the following violations:

1. Failed to maintain copies of the certificates of completion for the required security guard training skills for two of its security guards.

Order of Abatement

The Bureau hereby directs Hastings Patrol Services and Joe A. Onate to immediately cease and desist from violating BPC Sections 7583.2(c).

Upon receipt of this citation, you are to pay the following administrative fine(s):

Review of Citation

You may request a review by the Disciplinary Review Committee (DRC) to contest the assessment of the administrative fine per BPC 7581.3. A request for a review shall be by written notice to the Bureau within thirty (30) days of the issuance of the citation. The written request should be submitted to the Bureau at the following address:

Following the review by the DRC, you shall be notified within thirty (30) days, in writing, by regular mail, of the DRC's decision.

Hearing Request

If you disagree with the decision made by the DRC, you may request a hearing per BPC 7581.3. A request for a hearing, following a decision by the DRC, shall be by written notice to the Bureau within thirty (30) days of the DRC's decision. The hearing will be conducted in accordance with the provision of Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government code.

If you do not request a hearing within thirty (30) days, the DRC's decision shall become final.

Failure to Comply

Per BPC 125.9, failure to pay the fine within thirty (30) days after the date of service of the citation, unless the citation is being appealed, may result in disciplinary action being taken by the Bureau. If the citation is not contested and the fine is not paid, the full amount of the fine shall be added to the fee for renewal of the license. A license cannot be renewed without payment of the renewal fee and the fine.
