11 City of Merced (Participant).

12 **WHEREAS**, on May 16, 2022 the parties entered into Agreement No.
13 G-122891-A1 for the purchase of one (1) new alternative fuel vehicle.

14 **WHEREAS**, the parties wish to amend said Agreement.

15 **NOW, THEREFORE**, in consideration of their mutual promises, the
16 parties agree to amend said Agreement as follows:

17 1. The conditions of the contract in Section 3 shall not change:
18 "the total obligation of the District under this Agreement as follows: compensation "shall
19 not exceed **Nineteen Thousand Six Hundred And 00/100 dollars (\$19,600.00)**".

20 2. The conditions of the contract shall change as referenced in
21 Exhibit A attached hereto and referenced herein.

22 3. All remaining terms, provisions, covenants, conditions, and
23 promises contained in Agreement No. G-122891-A1 shall remain in full force and
24 effect.
