# RECOMMENDATION

**City Council** - Adopt a motion approving the Arts and Culture Advisory Commission's (ACAC) recommended Arts District in the City of Merced.

Public Information Officer Jennifer FLACHMAN, Arts and Culture Advisory Commissioners Tommy TRAN, and Colton DENNIS gave a presentation on the Arts and Culture Advisory Commission's proposal for Art's Districts in Merced. Council, Mr. TRAN, City Manager Stephanie DIETZ, and Mr. DENNIS discussed government factors of an Arts District, the funds allocated for art, developing an Arts Districts in South Merced, Downtown community outreach, South Merced community outreach, the requirements needed to turn Black Rascal Creek into an Arts District, details of different locations in Merced to bring art, protecting the history of art, and different policy directions.

Council agreed to start establishing an Arts District in Downtown Merced and South Merced and to explore all trails in Merced to create a trail Arts District.

SUBJECT: Council Member Ornelas' Request to Reconsider Re-Opening the Commercial Truck Parking Lot in the Airport Industrial Park at S. West Avenue and Stuart Drive

## **REPORT IN BRIEF**

Council Member Ornelas' request to reconsider re-opening and allowing commercial trucks to park in the Commercial Truck Parking Lot located off S. West Avenue.

## RECOMMENDATION

Provide direction to staff on next steps.

City Manager Stephanie DIETZ clarified that the Council is not taking action on the truck parking lot itself and explained that Council is potentially taking action to re-consider its previous decision.

Council Member ORNELAS gave a brief introduction to the request to reconsider re-opening the commercial truck parking lot.

Clerk's Note: The following comments were received via voicemail.

Teresa FRANCO, Merced - spoke in opposition of reopening the truck parking lot due to contamination of propane tanks and the health risks for kids.

Beatriz SOTELO, Merced - spoke in opposition of reopening the truck parking lot due to health risks and asked Council to vote no.

Ana Maria FABIAN, Merced - spoke in opposition of reopening the truck

parking lot and asked Council to fix the sidewalks, drainage, and water in South Merced.

Gerardo SOTELO, Merced - asked Council to consider not allowing truckers to park in South Merced due to issues arising.

Oscar SOTELO, Merced - spoke in opposition of reopening the truck parking lot due to crime, congestion, and the Riggs Ambulance barriers they face.

Lizette, Merced - expressed her concerns for reopening the truck parking lot due to littering, possible drug use, lack of community outreach, and increasing security in their home.

Micaela MENDOZA, Merced - spoke in opposition of reopening the truck parking lot due to safety concerns of children and the elderly.

Ariella SOTELO, Merced - urged Council to vote no on reopening the truck parking lot due to barriers for the ambulance and fire station, safety of children, and flammable products on trucks.

Janet MENDOZA, Merced - expressed her opposition of reopening the truck parking lot due to the health and safety concerns for children and the elderly.

Madeline HARRIS, Merced - encouraged Council to look for alternative parking due to air pollution in the area.

Brenda MCAFEE, Merced - spoke on her concerns on the commercial truck parking lot due to the safety of children.

Clerk's Note: The following speakers appeared in person.

Micaela MENDOZA, Merced - spoke in opposition of reopening the truck parking lot due to safety concerns of children and the elderly, speeding, air pollution, loud noises, and strangers.

Rachel Fuentes, Merced - asked Council to reconsider reopening the truck parking lot due to strangers soliciting, safety concerns for the youth and elderly, lack of sidewalks, and the barriers for Riggs and the fire station.

Monica SOTELO, Merced - spoke against reopening the truck parking lot

due to health and safety concerns, out of state truckers with bad behaviors, and adding fencing for extra security measures to homes, asked to find another location for truckers, and asked Council to reconsider reopening the truck parking lot.

Melissa MCAFEE, Merced - asked Council to reconsider reopening the truck parking lot due to safety concerns for children, pollution harming the elderly, the propane plant nearby, and asked to find a better parking lot for truckers.

Sonia SOTELO, Merced - spoke on the struggles Riggs Ambulance and the Fire Department go through due to the truck drivers in the area.

Robert DYLINA, Merced - spoke on the previous issue that caused Council to consider reopening the commercial truck parking lot, the issue of truck drivers parking in residential areas, and the air pollution that Highway 99 causes.

Steven GRAHAM, Merced - asked if there was a traffic study or environmental studies.

Council discussed alternative locations for truck parking lots, the community engagement, safety and lighting concerns, lack of community outreach, the commercial truck parking lot history and previous issues, and the increase of truck parking lot enforcement.

Council agreed to return on the October 2nd Council meeting to discuss alternatives, direction for fee policy changes, and potential action.
