

**FIRST AMENDMENT TO AGREEMENT
FOR PROFESSIONAL SERVICES**

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this 3rd day of July, 2023, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Hanson Bridgett LLP whose address of record is 425 Market Street, 26th Floor, San Francisco, California 94105 (hereinafter referred to as “Attorney”).

WHEREAS, Firm and the City previously entered into an Agreement for Professional Services (“Agreement”) dated July 3, 2023; and,

WHEREAS, the parties desire to amend the contract by increasing the not-to-exceed contracted amount from \$36,000 to \$100,000.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. The Agreement dated July 3, 2023, between the City and Firm shall be amended by increasing the not-to-exceed contracted amount from \$36,000 to \$100,000.
