C.1. Opening Comments by Mayor Matt Serratto and Planning Commission Chair Anthony Gonzalez

D.1. SUBJECT: Joint City Council/Planning Commission Study Session

Kicking Off the Comprehensive General Plan Update and the Merced

Downtown Station Area Plan

REPORT IN BRIEF

Presentation by consultants from Mintier Harnish to kick off the Comprehensive General Plan Update and the Merced Downtown Station Area Plan.

Acting Planning Manager Jonnie LAN, Management Analyst Leah BROWN, Consultant Brent GIBBONS, Consultant Michael GIBBONS, and Consultant Jim HARNISH gave a slideshow presentation on the role of Mintier and Harnish, the General Plan Amendment (GPA) Update, and the Downtown Station Area Plan Joint Study Session.

Council, Planning Commissioners, Mr. GIBBONS, Mr. HARNISH, Mr. GIBBONS, and Mrs. LAN discussed the grant due date from the High Speed Rail, the General Plan Amendment's role with existing plans in South Merced, the county or sphere of influence's affect on the GPA, future potential annexations, details of the High Speed Rail, the Downtown Station investment, and creating check-ins with the City Council and the Planning Commission. They also discussed details of the Vision and Goals, collaborating with Merced College, public engagement, details of social media posts, including Hmong translation, potentially redesigning the logo, collaborating with different cities, details of the engagement workshops, details of the appointment process for the Citizens Advisory Focus Group, and updating City Council.

Andrea URIBE, Leadership Counsel, Merced - asked for clarification on the chapters being updated in the General Plan, the plans that will be used, documents regarding the High Speed Rail project, and spoke on the environmental injustice.

Colton DENNIS, Merced - spoke on including arts and culture in the General Plan Amendment project.

Robert DYLINA, Merced - spoke on the previous General Plan Amendment that he participated in, receiving feedback from the public, and the annexations to the city.

Mayor SERRATTO and City Manager Scott MCBRIDE discussed details of the presentation given regarding the South Merced Study, details of the Senate Bill 244 Analysis, and details of the High Speed Rail Request for Proposal that was published.
