Alejandro CORTES, Merced - spoke in opposition of the proposed budget for fiscal year 2025-2026 and asked Council to invest in the residents of South Merced.

Gloria SANDOVAL, Merced - asked Council to clarify the Parks and Community Services Department's plan to move to the Senior Center, the timeline of the Merced Sun Star property, investing in Youth Services, and a solution to homelessness.

Curtis THOMAS, Merced - asked for clarification on the Parks and Community Services Department move to the Senior Center, the upcoming construction for the High Speed Rail, the excessive Workers Compensation claims, and spoke on the Microsoft software.

Mayor SERRATTO closed the Public Hearing at 9:27 PM.
