

**FOURTH AMENDMENT TO
LEGAL SERVICES AGREEMENT**

THIS FOURTH AMENDMENT TO LEGAL SERVICES AGREEMENT is made and entered into this ___ day of _____, 2026, by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Richards, Watson & Gershon, (“RWG”).

WHEREAS, City and RWG previously entered into a Legal Services Agreement (“Agreement”) dated February 20, 2024, for a total not to exceed amount of \$125,000;

WHEREAS, City and RWG entered into a First Amendment to Agreement dated April 15, 2024, to increase the total not to exceed contract amount from \$125,000 to \$195,000;

WHEREAS, City and RWG entered into a Second Amendment to Agreement dated June 16, 2025, to increase the total not to exceed contract amount from \$195,000 to \$231,000;

WHEREAS, City and RWG entered into a Third Amendment to Agreement dated February 17, 2026, to increase the total not to exceed contract amount from \$231,000 to \$291,000; and,

WHEREAS, City and RWG desire to amend said Agreement to provide for \$50,000 of additional compensation.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. The Agreement dated February 20, 2024, between the City and RWG shall be amended by increasing the not to exceed contracted amount from \$291,000 to \$341,000.

2. Except as herein amended, the Agreement dated February 20, 2024, First Amendment dated April 15, 2024, Second Amendment dated June 16, 2025, and Third Amendment dated February 17, 2026, shall remain in full force and effect.


