## THIRD AMENDMENT TO SALE AND/OR INSTALLATION AND SERVICES AGREEMENT

THIS THIRD AMENDMENT TO AGREEMENT is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2024, by and between the City of Merced, a California Charter Municipal Corporation ("City"), and Hoffman Electronic Systems, a California Corporation, ("Hoffman").

WHEREAS, City is in need of electronic monitoring services; and,

WHEREAS, City and Hoffman have previously entered into a Sale and/or Installation and Services Agreement ("Agreement") dated May 22, 2020; Change Order/Addendum No. 1 dated July 19, 2021, Change Order/Addendum No. 2 dated November 15, 2021, Change Order/Addendum No. 3 dated February 22, 2022, First Amendment dated March 30, 2022, Change Order/Addendum No. 4 dated May 2, 2022, and Second Amendment dated April 3, 2023; and,

WHEREAS, City and Hoffman desire to amend said Agreement to extend the term of the Agreement and providing additional compensation.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 29, "ADDITIONAL TERM," is hereby added to the Agreement to read as follows:

"SECTION 29. ADDITIONAL TERM. The City and Hoffman desire to extend the term of the Agreement for one (1) additional year. The additional term shall be from July 1, 2024 to June 30, 2025."

2. Section 30, "ADDITIONAL COMPENSATION," is hereby added to the Agreement to read as follows:

"SECTION 30. ADDITIONAL COMPENSATION. City shall pay to Hoffman the not to exceed additional sum of Twenty-Five Thousand Dollars (\$25,000.00) for the alarm monitoring period of July 1, 2024 to June 30, 2025 in accordance with the rates set forth on Exhibit '1' attached hereto."

Except as herein amended, the Agreement dated May 22, 2020; 3. Change Order/Addendum No. 1 dated July 19, 2021, Change Order/Addendum No. 2 dated November 15, 2021, Change Order/Addendum No. 3 dated February 22, 2022, First Amendment dated March 30, 2022, Change Order/Addendum No. 4 dated May 2, 2022, and Second Amendment dated April 3, 2023, shall remain in full force and effect.
