F.2 Traffic Committee Request #20-016- Request for Speed Control Implementation on El Portal Drive between Parsons Avenue and McKee Drive

Mr. HREN introduced the item, which was brought to the Bicycle and Pedestrian Advisory Commission at the request of the Traffic Committee. A citizen request for speed control created a conversation about the potential opportunity for a bicycle lane on El Portal Drive that utilizes parked cars as a buffer, potentially improving cyclist experience and reducing speeds by narrowing a uniquely wide roadway.

The Commission discussed the idea for the utilization of parked cars as a buffer for a bicycle lane in this area. The Commission directed staff that the idea as presented was not endorsed, due to a number of concerns with the proposal. These ranged from the continuity of the bicycle infrastructure in the area, to the severity of collisions when cyclists are screened by parked cars, to the unintended consequences and appropriateness of the proposed solution.

Some members of the Commission expressed an interest in exploring similar ideas for future issues, while others expressed concern that bicyclists' interests be the primary motivation behind addition of infrastructure rather than using bicycle lanes as a solution to other modes' existing issues. Ultimately, the Commission expressed gratitude to the Traffic Committee for bringing the matter to their attention, despite not being able to endorse the proposed implementation.

Commissioner HOTHEM discussed having a group ride on the reconstructed R Street once it opened to celebrate the improvement of this dilapidated infrastructure.

REPORT IN BRIEF

The Merced County Department of Public Health held a walk audit in South Merced, near Golden Valley High School, and wishes to present its results to the Bicycle and Pedestrian Advisory Commission.

DISCUSSION

The Merced County Department of Public Health partnered with Cal Walks and UC Berkeley SafeTREC to offer this Community Pedestrian and Bicycle Safety Training (CPBST). This community -led workshop worked with neighborhood residents and local agencies to develop walking and biking safety priorities and actionable next steps to improve walking and biking in their community.

The CPBST Fact Sheet and the Planning Committee commitments are attached, which provide an overview of the program and notes roles and responsibilities. A representative from the Department of Public Health will give a presentation at the meeting.

THE PROGRAM

Road design, traffic speed, and road/sidewalk quality are all factors that influence health, physical activity levels and the number of pedestrian and bicycle collisions that occur in our communities. Research also shows that deciding where and when to walk or bike on local streets and public areas to be active is shaped by how risky or safe we perceive them to be. Involving communities in data collection and decision-making processes is critical to promoting community investment in road safety and developing long term solutions to health concerns related to transportation.

The Community Pedestrian and Bicycle Safety Training (CPBST) program is a joint project of UC Berkeley SafeTREC and California Walks. The CPBST includes training and skill building in pedestrian and bicycle safety and creates opportunities for collaboration among communities, local officials and residents. The goal is to help make communities safer and more pleasant for walking and biking.

CPBST provided the space, time, and expertise Healthy Lompoc needed to convene stakeholders, build motivation and move our work forward. CPBST helped put data and credibility behind the message of increased safety and walkability in Lompoc."

WHAT TO EXPECT

The half day training is designed to provide participants with: 1) knowledge on how to conduct walking/biking assessments; 2) walking and biking safety countermeasures through the 6 E's safety approach: Equity and Community Empowerment, Evaluation, Engineering, Encouragement, Education, and Enforcement; and 3) an opportunity to address and plan for pedestrian and bicycle safety projects and programs with their community.

PART 1

Walking/Biking Assessments:



Participants take part in a walking/biking assessment of nearby streets.

PART 2

6 E's Educational Activity:



Participants then take part in an activity to discuss the 6 E's and how they relate to observations made during the walking/biking assessments.

PART 3

Table Talks Activity:



In smaller groups, participants reconvene to plan for infrastructure projects, community programs, and actionable next steps for their community.

RESULTS



- As of 2017, SafeTREC and California Walks have conducted 77 trainings.

Tell us about yourself, and why you are applying for this particular Board or Commission:

I am submitting this application to be accepted as an Ex-Oficio member of the Bicycle and Pedestrian Commission, because pedestrian safety in the City of Merced is a concern of mine. I am the Executive Director of Center of Vision Enhancement (COVE), a support and training center for the blind and those with a severe visual impairment. Pedestrian safety is a prime concern, since we walk the streets of Mercec to get to where we need to go. We have had clients hit by cars, or near misses as has occurred to myself, even when properly crossing within a crosswalk in observance of traffic controls. There are many areas within the City of Merced that are not "pedestrian friendly". I would bring to the commission the point of view of blind and visually impaired pedestrians, who live, work, and receive services in Merced.

Please list your current employer and relevant volunteer experience.

I am the Executive Director of the non-profit organization, Center of Vision Enhancement (COVE), Resource Center for the Blind and Low Vision. I have served on Merced County's Social Services Transportation Advisory Council for several years. I also volunteer for the Yosemite Gateway Council of the Blind and the California Council of the Blind.

What is your understanding of the roles and responsibilities of this Board or Commission?

I understand that my role would be a non-voting member of the Commission. I would act as an advisory capacity to provide the perspective of what is needed in merced to promote pedestrian safety, especially for those with limited or no sight. I could provide personal experiences and those of other blind/visually impaired persons as we interact with vehicles, scooters, bikes, skateboards, and other pedestrians while walking in Merced.

Do you have experience or special knowledge pertaining to this Board or Commission?

I am familiar with the public transportation systems in Merced. I have participated in groups involved with he Pedestrian Safety Act, reviewing access in transportation issues and "silent" car legislation.

Any other comments you would like to add that may assist the City Council in their decision?

I do not live in the city limits of Merced. I live in an unincorporated area of Merced County, but I work in Merced. I understand that a non-voting Ex-Oficio member is not required to live in the city limits. I am also a registered voter of Merced County. As a former educator, I would like to see more public education regarding pedestrian safety. This would include relearn the rules of being a pedestrian, such as not walking against traffic controls, and drivers needing to respect pedestrians. Education is needed on the "white cane" laws and what to do when you see a pedestrian traveling with a white cane. Drivers either ignore you or panic and slam on their brakes. Both instances are a safety concern for the pedestrian and the driver. Since we all share the road, I think it is important to consider all of our safety needs.
