RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MERCED ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 2003-2 (SERVICES) OF THE CITY OF MERCED CANVASSING THE RESULTS OF THE ELECTION HELD WITHIN ANNEXATION NO. 22 OF SAID DISTRICT

WHEREAS, the City Council of the City of Merced, California (the "Council"), acting as the legislative body of the Community Facilities District No. 2003-2 (Services) of the City of Merced (the "District"), has previously conducted proceedings pertaining to the annexation of certain property to the District ("Annexation No. 22"), the levying of a special tax pursuant to an amended rate and method of apportionment to finance the cost of providing certain public services and maintenance within Annexation No. 22 and the calling of an election in regard to the foregoing; and

WHEREAS, on January 17, 2023, an election was held within Annexation No. 22 of the District regarding annexing the property within Annexation No. 22 to the District, and the levying of the proposed special tax pursuant to the amended rate and method of apportionment of such proposed special tax; and

WHEREAS, at such election the annexation of Annexation No. 22 to the District, and the proposal for the amended rate and method of apportionment and the manner of levying and collecting the special tax for Annexation No. 22 were approved by the qualified electors of Annexation No. 22;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF MERCED, ACTING AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 2003-2 (SERVICES) OF THE CITY OF MERCED, AS FOLLOWS:

Section 1. It is hereby determined that the election conducted within Annexation No. 22 of the District was duly and validly conducted.

<u>Section 2.</u> The Council, acting as the legislative body of the District, is authorized to annex Annexation No. 22 to the District and to levy the special tax on behalf of the District on nonexempt property within Annexation No. 22.
