This Amendment is made and entered into this 22nd day of December, 2022, by and between the SAN JOAQUIN VALLEY UNIFIED AIR POLLUTION CONTROL DISTRICT, a unified air pollution control district formed pursuant to California Health and Safety Code section 40150 et seq. (District), and City of Merced (Participant).

**WHEREAS**, on May 16, 2022 the parties entered into Agreement No. G-122896-A1 for the purchase of one (1) new alternative fuel vehicle.

**WHEREAS**, the parties wish to amend said Agreement.

**NOW, THEREFORE**, in consideration of their mutual promises, the parties agree to amend said Agreement as follows:

1. The conditions of the contract in Section 3 shall not change: "the total obligation of the District under this Agreement as follows: compensation "shall not exceed **Five Thousand Twenty And 20/100 dollars (\$5,020.20)**".

2. The conditions of the contract shall change as referenced in Exhibit A attached hereto and referenced herein.

3. All remaining terms, provisions, covenants, conditions, and promises contained in Agreement No. G-122896-A1 shall remain in full force and effect.


