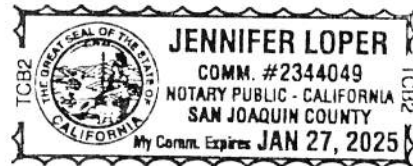

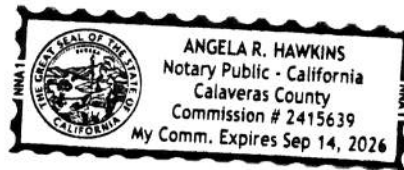

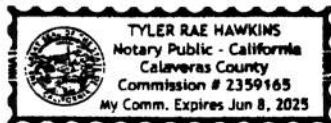

This outreach program is set forth in these Special Provisions. Bidders shall be fully informed concerning the requirements of this program. Failure to comply with the Good Faith Effort Outreach Program will render the bid non-responsive.

Please note that in accordance with the State Labor Law, the bidder is required to fill out the list of subcontractors (**Page 16**) at time of bid for any branch of work that is to be accomplished by persons or companies other than the general Contractor. This requirement is considered a totally separate issue from meeting the LBE requirements.

##### B. POLICY

The subcontracting outreach policy requires the bidder of this project to make a "Good Faith Effort" to obtain sub-bid participation by LBEs which is anticipated by the City to produce the level of LBE participation as shown in the "Notice Inviting Bids".

##### C. DEFINITIONS




