- Rain Barrels
- Pool Cover Rebates
- Irrigation Control Rebates

- Limitation on rebate amounts recommend no more than \$2,000/residential & \$10,000/commercial
- Require necessary receipts and documents to prove installation – reimbursement method

## **BROADBAND PROJECT**


- Merced County Needs Assessment Report Completed
  - 98% of City of Merced Residents have access to Broadband
- Evaluating several rounds of upcoming grant opportunities
  - Merced County Award LATA Grant of \$500,000
  - Last Mile Federal Funding Account = \$2 Billion
  - Broadband Equity, Access, and Deployment \$42 Billion
- Planning phase of grant applications to include developing a public-private partnership to provide high speed broadband to high need areas as defied by broadband grant programs.
- Recommend reserving \$1 million to match Capital Improvements related to future grant application
- The Golden State Network already under construction. 133 Miles of fiber optics planned throughout Merced County
- Golden State Connect authority (JPA) create by RCRC partnered with UTOPIA for Merced County Region
