

FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into this ____ day of _____, 2023 , by and between the City of Merced, a California Charter Municipal Corporation (“City”), and Provost & Pritchard Engineering Group, Inc., a California Corporation, (“Consultant”).

WHEREAS, City is undertaking a project to do assessment and remediation of PCE impacted sites; and,

WHEREAS, City and Consultant have previously entered into an Agreement for Professional Services (“Agreement”) dated July 5, 2022; and,

WHEREAS, City and Consultant desire to amend said Agreement to provide for additional services in connection with said project.

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants hereinafter recited, agree as follows:

1. Section 23, “ADDITIONAL WORK,” is hereby added to the Agreement to read as follows:

“SECTION 23. ADDITIONAL WORK. Consultant shall perform the additional work outlined in the proposal from Consultant to City dated January 19, 2023, attached hereto as Exhibit “1”.

2. Section 24, “ADDITIONAL COMPENSATION,” is hereby added to the Agreement to read as follows:

“SECTION 24. ADDITIONAL COMPENSATION. City shall pay to Consultant the not to exceed additional sum of Nineteen Thousand Eight Hundred Ninety Nine Dollars and Twenty-Seven Cents (\$19,899.27) for the additional work described in the proposal attached hereto as Exhibit “1”.

3. Except as herein amended, the Agreement dated July 5, 2022, shall remain in full force and effect.

Subject: PCE Remediation Parkway Cleaners – Compressor Replacement	

On January 12, 2023, P&P staff were onsite doing a teleconference with H2O Engineering staff to troubleshoot the operation of the air sparge trailer located behind the Parkway building. The sparge system was not working at full capacity and it was determined that one of the two compressors had seized and stopped working completely. Both compressors have been in service at Parkway since 2010. H2O Engineering recommended replacing both compressors at the same time to reduce their cost to return a second time. Both compressors are well past the expected service life. P&P is requesting additional budget for 2022/2023 fiscal year to cover the cost for two new compressors.

A scope and budget amendment is hereby submitted for Provost & Pritchard Consulting Group to incorporate the following changes:

PCE Remediation, Job No. 1511-22-001, Phase 02Q – Amendment

Additional tasks associated with workplan.

1. Two new compressors, 100 PSI Max Pressure, 2 HP, 11 CFM, 240 VAC 60 Hz 3 ph installed by H2O Engineering.
2. Project management and administration
