AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MERCED, CALIFORNIA, AMENDING SECTION 10.28.230, "NO PARKING ZONES" AND SECTION 10.28.300, "TWO-HOUR PARKING ZONES" OF THE MERCED MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN AS FOLLOWS:

SECTION 1. AMENDMENT TO CODE. Section 10.28.230, "No Parking Zones", of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

| South side of Alexander Avenue | Beginning at the western return of the driveway entrance to 634 E. Alexander Avenue, then westerly 8 feet. |
| South side of Alexander Avenue | Beginning at the eastern return of the driveway entrance to 634 E. Alexander Avenue, then easterly 8 feet. |

South side of Alexander Avenue

Beginning at the western return of the driveway entrance to 712 E. Alexander Avenue, then westerly to the eastern return of the driveway entrance to 686 E. Alexander Avenue.

South side of Alexander Avenue

Beginning at the eastern return of the driveway entrance to 712 E. Alexander Avenue, then easterly 8 feet.

South side of Alexander Avenue

Beginning at the western return of the driveway entrance to 730 E. Alexander Avenue, then westerly 8 feet.

South side of Alexander Avenue

Beginning at the eastern return of the driveway entrance to 730 E. Alexander Avenue, then easterly to the crosswalk.

South side of Alexander Avenue

Beginning at the western return of the driveway entrance to 756 E. Alexander Avenue, then westerly to the crosswalk.

South side of Alexander Avenue

Beginning at the eastern return of the driveway entrance to 756 E. Alexander Avenue, then easterly to the western return of the driveway entrance to 780 E. Alexander Avenue."

SECTION 2. AMENDMENT TO CODE. Section 10.28.300, "Two-Hour Parking Zones", of the Merced Municipal Code is hereby amended by adding the following portions of the following street:

"Street: Portion:

Both sides of Barclay Way Beginning at the southern line of Mandeville Lane, thence southerly to the northern line of Gilmore Drive."

SECTION 3. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 4. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 5. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.
